## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-NINE.

AN ACT to extend the Territorial Limits of the Dover and Foxcroft Village Fire Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. All that part of the territory embraced within 2 the following bounds and limits, viz: Beginning on the north 3 side of Essex street or Morse's road at Morse's southwest 4 corner, in Dover, thence running northerly on Morse's westerly 5 line to southerly line of the Bangor and Aroostook railroad 6 right of way, about four hundred and ten feet, thence on 7 southerly line of said Bangor and Aroostook railroad right of 8 way about eleven hundred and sixty feet to the east line of lot 9 nine range one in Foxcroft, thence northerly on east line of

10 said lot nine range one about one hundred and forty rods to the 11 southeast corner of lot nine range two, thence northerly on 12 east line of lot nine range two eleven hundred and fifty feet, 13 thence westerly parallel with the south line of lots nine, ten, 14 eleven and twelve range two to the west line of lot twelve 15 range two, thence southerly on west line of lot twelve range 16 two and lot twelve range one to Piscataquis river, thence down 17 said river about one hundred rods to Charles V. Wilson's west 18 line, thence southerly on said Wilson's west line to Pine street 19 or road leading by the residence of Volney A. Gray, thence 20 easterly on said Pine street to the west line of lot two range 21 twelve in Dover, thence southerly on said west line to south-22 west corner of said lot two range twelve, thence southerly on 23 west line of lot four range eleven, one thousand feet, thence 24 parallel with south line of lots two, three and four range twelve 25 to road leading over Woodbury hill to Dover South Mills, thence 26 northerly on said road to south line of lot five range twelve, 27 thence easterly on said south line of lot five range twelve to 28 southeast corner of lot five range twelve, thence northerly on 29 east line of lot five range twelve to northeast corner of lot five 30 range twelve, thence westerly on north line of lot five range 31 twelve to point begun at, which is not included in the present 32 territory and corporate limits of the Dover and Foxcroft Village 33 Fire Company, incorporated by chapter two hundred and sixty-34 two of the Private and Special Laws of 1863, together with the 35 inhabitants thereon, is hereby added to and made a part of 36 said Dover and Foxcroft Village Fire Company, with all the 37 rights, privileges and obligations of said corporation.

SECT. 2. This act shall take effect when approved.
