STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ONE.

AN ACT to regulate winter fishing and to close the tributaries
of certain lakes and ponds in Piscataquis county.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. It shall be unlawful to fish through the ice
2 at any time for any kind of fish in any of the lakes or
3 ponds lying wholly or partly in the county of Piscataquis,
4 except in the following named lakes and ponds, to wit:
5 Boyd lake, Seboeis lake, Cedar lake, Ebeeme ponds,
6 Schoodic lake, North and South Twin lakes, Pamadum-
7 cook lake, Ambajejus lake, Debsconeag lake, Nahmakanta
8 lake, Chesuncook lake, Sebec lake, First Buttermilk pond,
9 Big Benson pond, Big Huston pond, Center pond in
10 Sangerville, Moosehead lake, Jo Mary lake, Caribou lake,

11 Lobster lake, Chamberlain lake, Telos lake, Webster lake,
12 Eagle lake, Allegash lake, Munsungan lake, Millinockett
13 lake, Caucongomoc lake, Churchill lake, Chemquassabanti-
14 cook lake, Grand lake, Second lake, Ragged lake, Pepper
15 pond, Whetstone pond, in which lakes and ponds it shall
16 be lawful during February, March and April for citizens
17 of this state to fish for and take fish therein, with not more
18 than five set lines for each family when fishing through
19 the ice in the day time, and when under the immediate
20 personal superintendence of the person fishing, and may
21 convey them to their own homes for consumption therein
22 but not otherwise ; but no one during this time shall be
23 permitted to catch more than twenty pounds, or one fish,
24 of land-locked salmon, togue or trout in any one day.

Sect. 2. In addition to the tributaries to certain lakes
2 and ponds in this county now closed by law it shall be
3 unlawful to take, catch or kill any kind of fish at any
4 time in Davis stream in Willimantic, Monson pond stream
5 which is a tributary to Davis stream, Vaughan stream
6 which is a tributary to Long pond stream.

Sect. 3. Section five of chapter forty-two of the Public
2 Laws of eighteen hundred and ninety-nine, so far as it
3 relates to ice fishing in Piscataquis county, is hereby
4 modified to conform to the provisions of this act.

Sect. 4. Whoever violates any of the provisions of this
2 act shall be subject to a fine not exceeding thirty dollars
3 and not less than ten dollars, and in addition thereto, to a
4 penalty of one dollar for each fish caught, taken or killed
5 in violation thereof.
