STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ONE.

AN ACT to fix the terms of the Supreme Judicial Court in
the counties of Franklin, Knox, Sagadahoc, Somerset and
York.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

FRANKLIN COUNTY.

Section one of chapter two hundred and twenty-two of
2 the Public Laws of eighteen hundred and ninety-three is
3 hereby amended to read as follows :

Sect. 1. The supreme judicial court shall hereafter be
5 held at Farmington within and for the county of Franklin,
6 on the first Tuesday of February, third Tuesday of May
7 and fourth Tuesday of September, annually, instead of
8 the times now provided by law.

KNOX COUNTY.

In section 47 of chapter 77 of the Revised Statutes, that
2 paragraph relating to times of holding terms of the
3 supreme judicial court in the county of Knox is amended
4 to read as follows :

Knox, at Rockland, on the second Tuesday of March,
6 third Tuesday of September and fourth Tuesday of
7 December.

SAGADAHOC COUNTY.

In section 47 of chapter 77 of the Revised Statutes, that
2 paragraph relating to times of holding terms of the
3 supreme judicial court in the county of Sagadahoc is
4 amended to read as follows :

Sagadahoc, at Bath, on the first Tuesday of April, the
6 third Tuesday of August and the fourth Tuesday of
7 December.

SOMERSET COUNTY.

In section 47 of chapter 77 of the Revised Statutes, that
2 paragraph relating to times of holding terms of the
3 supreme judicial court in the county of Somerset is
4 amended to read as follows :

Somerset, at Skowhegan, on the third Tuesdays of
6 March and September and the fourth Tuesday of
7 December.

YORK COUNTY.

In section 47 of chapter 77 of the Revised Statutes, that
2 paragraph relating to times of holding terms of the
3 supreme judicial court in the county of York is amended
4 to read as follows :

York, at Saco, on the first Tuesday of January, and at
6 Alfred on the first Tuesday of May and the third Tuesday
7 of September.
