IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ONE.

RESOLVE making appropriations for the Passamaquoddy tribe of Indians.

Resolved, That there be paid from the state treasury to be

- 2 expended under the direction of the governor and council
- 3 to the agent of the Passamaquoddy tribe of Indians, for the
- 4 benefit of said tribe, for the years nineteen hundred and one
- 5 (1901) and nineteen hundred and two (1902) as follows:
- 6 For May dividend, four hundred dollars each year.
- 7 For November dividend, four hundred dollars each year.
- 8 For distressed and contingent poor, four thousand dollars
- 9 each year.
- 10 For contingent purposes, one hundred and fifty dollars each
- II year.
- 12 For bounty on crops, two hundred dollars each year.

- 13 For plowing, one hundred and fifty dollars each year.
- 14 For salary of governor, one hundred dollars each year.
- 15 For salary of lieutenant-governor, forty dollars each year.
- 16 For salary of priest, two hundred dollars each year.
- 17 For salary of agent, two hundred dollars each year.
- 18 for fertilizers, one hundred and fifty dollars each year.
- 19 For educational purposes, eight hundred dollars each y ear.
- 20 For basket ash, three hundred and fifty dollars each year.
- 21 For wood, six hundred and fifty dollars each year.
- 22 For agricultural purposes, six hundred dollars each year.
- 23 For police, fifty dollars each year.
- 24 For school books, thirty dollars each year.
- 25 For repair of schoolhouse, Pleasant Point, in nineteen
- 26 hundred and one, fifty dollars.
- 27 For painting town hall, Pleasant Point, in nineteen hundred
- 28 and one, twenty-five dollars.
- 29 For repair of road, Pleasant Point, in nineteen hundred and
- 30 one, thirty dollars.
- 31 For repair of sisters' home, Peter Dana's Point, in nineteen
- 32 hundred and one, twenty-five dollars.
- 33 For repair of road, Peter Dana's Point, in nineteen hundred
- 34 and one, two hundred dollars.
- 35 For repair of road, Peter Dana's Point, in nineteen hundred
- 36 and two, fifty dollars.

All the foregoing sums to be expended under the direction

- 38 of governor and council, for the purposes for which they
- 39 were appropriated, and for none other, and any money not
- 40 expended for the purposes for which it is appropriated, shall
- 41 not be allowed to said agent in the settlement of his account.
