STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ONE.

AN ACT to provide for a board of Pan-American managers, of the Pan-American Exposition of nineteen hundred and one, and to defray the expenses thereof.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. That for the purpose of exhibiting the resources, 2 products and general development of the state of Maine at 3 the Pan-American Exposition of nineteen hundred and one, 4 to be holden at Buffalo in the state of New York, a commis-5 sion is hereby constituted to be designated the Board of Pan-6 American Managers of Maine which shall consist of five 7 residents of the state of Maine.

Sect. 2. The members of said board shall be appointed by 2 the governor within five days after the approval of this act, 3 one of whom shall be designated as chairman, one as secre-4 tary, and one as treasurer.

The treasurer of said board shall give bond to the state in 6 the sum of five hundred dollars, with sureties to be approved 7 by the governor for the proper performance of his duties.

Any member of said board may be removed by the governor 9 for cause and any vacancy may be filled by the governor.

Sect. 3. The members of the board appointed under this 2 act shall not be entitled to any compensation for their ser-3 vices, out of the state treasury, except their actual expenses 4 for transportation and five dollars a day for subsistance for 5 each day they are necessarily absent from their homes on the 6 business of said board.

Sect. 4. The said board shall have charge of the interests 2 of the state, and its citizens in the preparation and exhibition 3 at said exposition of the natural and industrial products of 4 the state and of objects illustrating its history, progress, 5 moral and material welfare and future development, and in 6 all other matters relating to said Pan-American Exposition.

Sect. 5. The said board shall make a report of its 2 proceedings and expenditures, from time to time, to the gov-3 ernor.

Sect. 6. To carry out the provisions of this act the sum of
2 six thousand dollars, or so much thereof as may be necessary,
3 is hereby appropriated, three thousand dollars of which shall
4 be expended in conjunction with such of the other New

5 England states as may appropriate, either by state appropri6 ation or private subscription a like amount, in the erection of
7 a building on the grounds of said exposition, to be designated
8 as the New England building, or such other appropriate name
9 as the managers of the New England states may designate.

The balance, or such part thereof as may be necessary, to 11 be expended in fitting and furnishing a suite of rooms in said 12 building in a manner suitable to meet the requirements and 13 purposes of this act, and to defray the expenses of the said 14 managers, under the limitations of section three of this act.

Sect. 7. This act shall take effect when approved.
