STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ONE.

AN ACT pertaining to ice fishing in certain lakes and ponds
in Kennebec County.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. It shall be lawful for citizens of this state to
2 fish through the ice, in the day time, with not more than
3 five set lines to a family, and when under the immediate
4 personal control of the person fishing, and to catch not
5 exceeding twenty pound or one fish in any one day, and
6 convey the same to their own homes for consumption
7 therein but not otherwise, in the following named lakes
8 and ponds situated wholly or partly in Kennebec county,
9 to wit:

All of the ponds and lakes situated wholly or partly in 11 the town of Sidney; Cochnewagon pond in Monmouth, 12 Dexter, Beriy, Ford, Pickerel and Wayne pond situated 13 wholly or partly in the town of Wayne; also all of the 14 lakes or ponds situated in Readfield with the exception of 15 Lake Maranocook; also all of the lakes and ponds situated 16 wholly or partly in the town of Litchfield with the excep- 17 tion of Jimmy pond, so called; also all of the lakes and 18 ponds situated on the east side of the Kennebec river in 19 Kennebec county, with the exception of Three Mile pond, 20 so called, in China, Windsor and Vassalboro, in which 21 last named pond it shall be lawful to catch pickerel on 22 Saturdays only of each week, also Horseshoe pond in 23 West Gardiner; but nothing in this act shall be construed 24 as permitting ice fishing at any time in Lake Cobbossee- 25 contee, situated partly in Monmouth, Winthrop, Man- 26 chester, West Gardiner and Litchfield.

Sect. 2. Whoever violates any of the provisions of this 2 act shall be subject to the same penalties as are provided 3 for illegal fishing in the general law.

Sect. 3. All acts or parts of acts inconsistent with this 2 act are hereby repealed.
