AN ACT to incorporate the trustees of Coburn Classical  
Institute

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. Nathaniel Butler, Franklin W. Johnson, George  
2 D. B. Pepper, Horace Purinton, Leslie C. Cornish, Edwin C.  
3 Whittemore, Horatio R. Dunham and Cyrus W. Davis are  
4 hereby created a corporation by the name of Trustees of  
5 Coburn Classical Institute, for the purpose of maintaining a  
6 literary institution in the city of Waterville with all the  
7 powers of similar corporations, including the power to make  
8 and establish by-laws and regulations for the management  
9 of its affairs and the proper government of the institution.

Sect. 2. Said corporation shall be governed and its powers  
2 exercised by a board of not exceeding seventeen trustees, of  
3 which the president of Colby College and the principal of  
4 Coburn Classical Institute for the time being shall, ex-officio,  
5 be members. At the organization of the corporation, the  
6 number of other trustees shall be fixed by the by-laws and  
7 shall be divided as nearly as may be into three classes; one  
8 class shall be elected for one year, one for two years and one  
9 for three years; and at each annual meeting thereafter, mem-  
10 bers shall be elected by the board in place of those whose  
11 terms shall expire, and any vacancies in the other classes  
12 shall be filled.

Sect. 3. Said corporation may use the real estate held in  
2 trust for it, and the income of all funds held in trust for it,  
3 by the president and trustees of Colby College, in accordance  
4 with the trust by which they are so held and with such  
5 arrangements as shall from time to time be made with said  
6 president and trustees; and may also take and hold, for the  
7 purposes of its creation, property in its own right to the  
8 amount of one hundred and fifty thousand dollars.

Sect. 4. This act shall take effect when approved.
