IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND ONE.

AN ACT to Extend the Charter of the Waldoboro Water  
and Electric Light and Power Company.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. The Waldoboro Water and Electric Light and  
2 Power Company is hereby granted an extension of two  
3 years from and after the approval of this act in which to avail  
4 itself of the rights, powers, privileges and immunities here-  
5 tofore granted to said company by chapter five hundred  
6 and ninety of the Private and Special Laws of the state of  
7 Maine for the year eighteen hundred and ninety-three, and  
8 by all acts additional thereto and amendatory thereof, all of  
9 which acts are hereby revived; and the organization of said

10 company under said acts is hereby ratified, confirmed and  
11 made valid.

Sect. 2. At any time within five years from the date of the  
2 approval of this act the town of Waldoboro, if its inhabitants  
3 shall so vote, by a two-thirds vote, at a legal town meeting  
4 called therefor shall have the right to purchase the system of  
5 water works constructed by this company in said town for  
6 supplying said town and the inhabitants thereof, together  
7 with the franchises of this company relating thereto, at a  
8 price to be agreed upon between said company and said  
9 town; and if such price cannot be agreed upon, then at a  
10 price, not less than cost, which shall be determined by a  
11 commission of three competent and disinterested men, one  
12 of whom shall be selected by said company, one by said  
13 town of Waldoboro, and the third by the two so selected if  
14 they can agree, if not, then by the chief justice of the  
15 supreme judicial court of Maine. The award of said com-  
16 missioners, not less than cost, shall be binding upon said  
17 company and said town, and said town shall pay the amount  
18 of said award for said system of water works and franchises  
19 within ninety days from the date when said award shall be  
20 rendered. The cost of said commission shall be borne  
21 equally by the said company and said town.

Sect. 3. This act shall take effect when approved.
