STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ONE.

AN ACT in relation to the annual town meeting of the Town of Boothbay Harbor.

Be it enacted by the Senate and House of Refresentatives in Legislature assembled, as follows:

Section 1. The town of Boothbay Harbor is hereby author-2 ized to hold its annual town meeting on the second Monday

- 3 in January and shall hold said meeting annually on said day
- 4 for the performance of all duties required by law to be per-
- 5 formed in March, provided this act is accepted as hereinafter
- 6 provided.
- Sect. 2. The duties required of the selectmen of said town
- 2 under section eleven of chapter four of the Revised Statutes
- 3 shall be performed on or before the twentieth day of De-
- 4 cember annually.

- Sect. 3. 'The duties required of the selectmen of said town 2 under section twelve of chapter four of the Revised Statutes 3 shall be performed on the secular day next preceding said 4 second Monday of January or on the morning of said day.
- Sect. 4. The inhabitants of said town may at said January 2 meeting annually appoint their treasurer a collector of taxes 3 as provided by section one hundred and seventy-six of chapter six of the Revised Statutes.
- Sect. 5. The duties required of the road commissioner of 2 said town, if any such officer is elected, required by section 3 six of chapter thirty-two of the Public Laws of eighteen 4 hundred and ninety-nine to be performed on or before the 5 twentieth day of February annually shall be performed on or 6 before the twentieth day of December annually.
- Sect. 6. The said town at its annual meeting in January 2 aforesaid shall have all the powers and be subject to all the 3 duties of towns at their annual March meetings as now or 4 hereafter regulated by law.
- Sect. 7. The foregoing sections of this act shall not take 2 effect until the same shall be accepted by major vote of the 3 legal voters of said town present and voting at the annual 4 meeting of said town in March, nineteen hundred and two, 5 an appropriate article therefor having been first inserted in 6 the warrant therefor. The town clerk shall certify the action 7 of such meeting to the secretary of state. If said major vote 8 is so adopted, the tenure of all officers elected at such meet-9 ing shall be determined by the provisions of this act.
- Sect. 8. For the purposes of section seven this act shall take 2 effect when approved.
