STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ONE.

AN ACT to amend chapter sixty of the Public Laws of eighteen hundred and ninety-five, entitled "An Act to amend chapter twenty-one of the Public Laws of eighteen hundred and eighty-seven, entitled 'An Act to amend chapter two hundred and eighty of the Public Laws of eighteen hundred and eighty-five, entitled 'An Act amendatory to section twenty-nine of chapter ninety-one of the Revised Statutes, relating to Liens.'"

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section twenty-nine of chapter ninety-one of the Revised
2 Statutes, as amended by chapter two hundred and eighty of
3 the Public Laws of eighteen hundred and eighty-five, as
4 amended by chapter twenty-one of the Public Laws of eight-

5 een hundred and eighty-seven, as amended by chapter sixty
6 of the Public Laws of eighteen hundred and ninety-five, is
7 hereby further amended by striking out the words "and" and
8 "or" in the first line of said section, as amended, and also
9 by striking out the word "or" after the word "cutting" and
10 before the word "yarding" in the second line of said section,
11 as amended, and by adding after the word "yarding" in the
12 first and second lines of said section, as amended, the words
13 'or hauling' and also by adding after the word "yarding" and
14 before "cord" in said second line the words 'or hauling,' so
15 that said section, as amended, shall read as follows:

'Sect. 29. Whoever labors at cutting, peeling, yarding or
17 hauling hemlock bark, or cutting, yarding or hauling cord
18 wood, or at cooking for persons engaged in such labor, has a
19 lien thereon for the amount due for his personal services and
20 the services performed by his team, which takes precedence
21 of all other claims, continues for thirty days after the con-
22 tract is completed, and may be enforced by attachment; pro-
23 vided, however, that such lien shall not continue after the
24 bark or wood has arrived at a market.'
