STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ONE.

AN ACT relating to the Mallison Power Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The Mallison Power Company, a corpora-2 tion duly incorporated under the General Laws of this 3 state, in addition to the rights obtained thereby, and for 4 the purposes contemplated in its original incorporation 5 and in this act, is hereby authorized and empowered to 6 issue its bonds or other evidences of indebtedness in such 7 amounts and on such times and rates as it may from time

8 to time determine, and secure the same, by mortgage of 9 its property and franchises; increase its capital stock to 10 any amount not prohibited by law, as it deems necessary; 11 acquire in any legal manner and hold, sell, lease or other-12 wise convey all real and personal property and rights 13 including the shares of the capital stock and bonds of 14 other corporations, necessary, proper or convenient for 15 all said purposes, and vote upon said stock while so held, 16 and is also authorized and empowered to carry on the 17 business of making, generating, using, selling, distribut-18 ing, transmitting and supplying electricity for lighting, 19 heating, manufacturing and all other legal purposes; and 20 in the prosecution thereof to locate, construct, maintain, 21 keep in repair and operate its lines with suitable poles, 22 supports, wires, conduits and other apparatus, upon, 23 along, across, over or under any public highway, bridge, 24 railroad or private land that it may find necessary or con-25 venient to accomplish any of the purposes aforesaid in 26 the cities and towns of Westbrook, Windham, Gorham, 27 Standish and Cumberland in the county of Cumberland in 28 this state; but in such manner as not to unnecessarily 29 incommode or endanger the public use thereof, first hav-30 ing obtained the consent of the proper municipal officers 31 of any city or town to such use of any highway or bridge 32 therein, and the consent of the officers of any railroad 33 and the owners of any private land on which it is pro-34 posed to build its lines with the right to remove trees and

35 other obstructions, when necessary, within the limits and 36 for the purposes aforesaid except fruit trees or any tree or 37 shrub standing and growing for the purposes of shade or 38 ornament.

Sect. 2. This act shall take effect when approved.
