STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ONE.

AN ACT to authorize the county commissioners of Somerset county to borrow a sum of money with which to build an extension to the court house in Skowhegan, in said county.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The treasurer of the county of Somerset is
2 hereby authorized to procure a loan, on the faith and re-
3 sponsibility of said county, of such sum or sums of money
4 as the county commissioners of said county shall by order
5 direct, not exceeding in all fifteen thousand dollars, ex-
6 clusive of and in addition to loans provided for by section
7 seventeen of chapter seventy-eight of the Revised Statutes,

8 as amended by chapter two hundred and seventy-six of the
9 Public Laws of the State of Maine for the year 1889, to
10 be expended by and under the direction of the county
11 commissioners of said county for the purpose of enlarging,
12 improving and repairing the county court house and
13 appurtenances thereof, in said county, the interest on said
14 sum or sums to be paid annually, and the principal to be
15 reimbursed by said county at such time or times as said
16 commissioners may agree upon, but the whole amount to
17 be paid within twenty years; and the said treasurer is
18 hereby authorized to issue his scrip as county treasurer
19 therefor, with coupons for interest attached, or to issue
20 interest bearing, negotiable promissory notes of said county
21 therefor, payable in manner as aforesaid, such scrip, and
22 coupons and notes to be signed by the treasurer and
23 countersigned by the county commissioners of said county.

Sect. 2. But said county commissioners shall not
2 authorize the loan hereinbefore provided until after notice
3 and public hearing thereon by said county commissioners,
4 which hearing shall be given at the court house in Skow-
5 hegan the second Tuesday of June, 1901, and notice
6 thereof, setting forth the time, place and purposes of said
7 hearing shall be given by publication in each and every
8 newspaper published in said county, the first publication in
9 each newspaper to be at least thirty days before said
10 hearing.

Sect. 3. This act shall take effect when approved.
