STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT extending sundry existing statutes to Street Railroads.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section ten of chapter two hundred and sixty-

- 2 eight of the Public Laws of one thousand eight hundred and
- 3 ninety-three, as amended by section three of chapter two
- 4 hundred and forty-nine of the Public Laws of one thousand
- 5 eight hundred and ninety-seven, is further amended by insert-
- 6 ing the words 'eighteen as amended by chapter one hundred
- 7 and twenty-nine of the Public Laws of one thousand eight
- 8 hundred and ninety-one' between the words "seventeen" and
- 9 "nineteen," by inserting the word 'twenty-one' between the
- 10 words "twenty" and "twenty-two," by striking therefrom the

11 word "sixty-eight," by inserting the words 'seventy-eight, 12 seventy-nine, eighty, one hundred and nine' between the 13 words "sixty-eight' and "one hundred and fourteen" and 14 by inserting between the words "statutes" and "shall" the 15 words 'chapter two hundred and thirty-six of the Public 16 Laws of one thousand eight hundred and ninety-three,' so 17 that the said section as hereby amended shall read as follows:

'Sect. 10. So far as applicable the provisions of sections 19 seventeen, eighteen as amended by chapter one hundred and 20 twenty-nine of the Public Laws of one thousand eight hun-21 dred and ninety-one, nineteen, twenty, twenty-one, twenty-22 two, twenty-three, twenty-four, twenty-five, twenty-six, 23 twenty-seven, thirty-six, thirty-seven, thirty-eight, thirty-24 nine, fifty-four, fifty-five, fifty-six, fifty-seven, sixty-six, 25 sixty-seven, seventy-eight, seventy-nine, eighty, one hundred 26 and nine, one hundred and fourteen, one hundred and fifteen, 27 one hundred and sixteen, one hundred and seventeen, one 28 hundred and eighteen, one hundred and twenty-six, one hun-29 dred and thirty-five, one hundred and thirty-six as amended, 30 one hundred and thirty-seven, one hundred and thirty-eight, 31 one hundred and thirty-nine, one hundred and forty of chap-32 ter fifty-one of the Revised Statutes, and chapter two hundred 33 and thirty-six of the Public Laws of one thousand eight hun-34 dred and ninety-three shall apply to street railways.'

Section 2. In all proceedings now pending or hereafter 2 brought before the county commissioners for the estimation 3 of damages for the taking of land by any street railroad com-

4 pany described in the location of such company now on file, 5 as required by law, section twenty-one of chapter fifty-one 6 of the Revised Statutes and chapter two hundred and thirty-7 six of the Public Laws of one thousand eight hundred and 8 ninety-three shall be applicable thereto.

Sect. 3. This act shall take effect when approved.
