STATE OF MAINE.

RESOLVES in relation to the completion of the fifth revision of the General and Public Laws, and appointing a commissioner therefor.

Resolved, That John A. Morrill, of Auburn, be appointed
2 a commissioner to complete the revision of the General and
3 Public Laws of the State, incorporating the Public Laws of
4 the present session, and to complete the index of the same,
5 correcting the notes and marginal annotations of sections to
6 correspond with the final draft of the revision; preparing
7 marginal notes and references for new sections; adding refer-
8 ences to all appropriate cases reported in the ninety-sixth
9 volume of Maine Reports and subsequent volumes and to
10 all decisions interpreting the constitution of the United States
11 and of the State of Maine which appear in the one hundred
12 eighty-third volume of the reports of the supreme court of
13 the United States and subsequent volumes; and carefully to
14 superintend the printing of said revision and index, with

15 such additions as may be made under the provisions of these
16 resolves.

Resolved, That the foregoing work be performed by said
18 commissioner under the supervision of Forrest Goodwin,
19 George C. Wing, Howard Pierce, Beecher Putnam, Artemus
20 Weatherbee, Henry W. Oakes, John W. Manson, Lincoln H.
21 Newcomb, Natt T. Abbott and S. S. Thornton, members of
22 the joint select committee of the present legislature on the
23 revision of the statutes, who are hereby constituted a com-
24 mission to sit during the recess of the legislature for that
25 purpose, and to continue the work of said committee of the
26 legislature for the completion of their work and the perfec-
27 tion of the revision.

Resolved, That the governor and council are hereby author-
29 ized to audit and cause to be paid, the services and expenses
30 of said Morrill and said commissioners and of such clerks
31 and other assistants as it may be necessary for said Morrill
32 or said commissioners or committee to employ.

Resolved, That if said Morrill declines said duty, or becomes
34 unable to perform it, the governor and council shall appoint
35 some other suitable person to fill the vacancy, and do the
36 duties herein prescribed for said Morrill.
