STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to amend chapter 284 of the Public Laws of 1901 relating to Sea and Shore Fisheries.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section 21 of chapter 284 of the Public Laws 2 of 1901 is hereby amended by striking out the last sentence 3 thereof and inserting the following sentences: "The posses-4 sion of mutilated lobsters, cooked or uncooked, shall be prima 5 facie evidence that they are not of the required length.

'All lobsters or parts of lobsters sold for use in this State 7 or for export therefrom must be sold and delivered in the 8 shell under a penalty of twenty dollars for each offense, and 9 whoever ships, buys, gives away, sells or exposes for sale,

10 lobster meat after the same shall have been taken from the 11 shell shall be liable to a penalty of one dollar for each pound 12 of meat so bought, sold, given away, exposed for sale or 13 shipped. Any person or corporation in the business of a 14 common carrier of merchandise, who shall knowingly carry 15 or transport from place to place lobster meat after the same 16 shall have been taken from the shell shall be liable to a pen-17 alty of fifty dollars upon each conviction thereof. All lob-18 ster meat so illegally bought, shipped, sold, given away, 19 exposed for sale or transported shall be liable to seizure and 20 may be confiscated.

'Nothing contained herein, shall be held to prohibit the sale' 22 of lobsters that have been legally canned,' so that said section 23 as amended shall read as follows:

'Sect. 21. It is unlawful to catch, buy or sell, give away or 25 expose for sale, or possess for any purpose any lobster less 26 than ten and one-half inches in length, alive or dead, cooked 27 or uncooked, measured in manner as follows: taking the 28 length of the back of the lobster, measured from the bone 29 of the nose to the end of the bone of the middle flipper of 30 the tail, the length to be taken in a gauge with a cleat upon 31 each end of the same, measuring ten and one-half inches 32 between said cleats, with the lobster laid and extended upon 33 its back the natural length upon the gauge, without stretch-34 ing or pulling, and any lobster shorter than the prescribed 35 length when caught shall be liberated alive at the risk and 36 cost of the parties taking them, under a penalty of one dollar 37 for each lobster so caught, bought, sold, exposed for sale or 38 in possession. The possession of mutilated lobsters, cooked 39 or uncooked, shall be prima facie evidence that they are not 40 of the required length.

'All lobsters or parts of lobsters sold for use in this State 42 or for export therefrom must be sold and delivered in the 43 shell under a penalty of twenty dollars for each offense, and 44 whoever ships, buys, sells, gives away or exposes for sale, 45 lobster meat after the same shall have been taken from the 46 shell shall be liable to a penalty of one dollar for each pound 47 of meat so bought, sold, exposed for sale, given away or 48 shipped. Any person or corporation in the business of a 49 common carrier of merchandise, who shall knowingly carry 50 or transport from place to place lobster meat after the same 51 shall have been taken from the shell shall be liable to a pen-52 alty of fifty dollars upon each conviction thereof. All lob-53 ster meat so illegally bought, shipped, sold, given away, 54 exposed for sale or transported shall be liable to seizure and 55 may be confiscated.

'Nothing contained herein shall be held to prohibit the sale 57 of lobsters that have been legally canned.'

Sect. 2. Section twenty-three is hereby amended so that 2 said section, as amended, shall read as follows:

'It shall be unlawful to can, lobsters less than ten and one-4 half inches in length, alive or dead, measured as aforesaid; 5 and for every lobster canned, contrary to the provisions of 6 this section, every person, firm, association or corporation so 7 canning, shall be liable to a penalty of one dollar for every 8 lobster so canned, contrary to the provisions of this section, 9 and a further penalty of three hundred dollars for every day 10 on which such unlawful canning is carried on.'
