IN THE YEAR OF OUR LORD ONE THOUSAND NINE

AN ACT to enlarge the powers of the Prouts Neck Water  
Company.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. The Prouts Neck Water Company, incorpo-  
2 rated under chapter 490 of the Private and Special Laws  
3 of Maine approved March 22, 1901, is hereby authorized  
4 to make, generate, sell, distribute and supply gas or  
5 electricity, or both, for lighting, heating, manufacturing  
6 and mechanical purposes, and to supply that part of the  
7 town of Scarborough in the county of Cumberland which  
8 is situate and lies south of the eastern division of  
9 the Boston & Maine railroad, and the inhabitants thereof,

10 with electric light and electric power, and to carry on the  
11 business of lighting by electricity or otherwise such public  
12 streets in the territory aforesaid and such buildings and  
13 places therein, public and private, as may be agreed upon  
14 by said corporation and the owners or those having con-  
15 trol of such places to be lighted, and of furnishing power  
16 by electricity or otherwise within said territory ; and may  
17 build and operate factories and works for providing and  
18 supplying electric light and power, and may take, lease,  
19 purchase and hold real estate and personal estate therefor,  
20 and construct, lay, maintain and operate lines of wire or  
21 other material for the transmission of electricity or power  
22 upon, along, and over any and all streets and ways, under  
23 the direction of the municipal officers of said town.

Sect. 2. This act shall take effect when approved.

Notice is hereby given that the undersigned, or some persons in its behalf, will ask the legislature of Maine for the year 1903, for the passage of a special act authorizing the making, generating, selling, distributing and supplying of gas or electricity or both, for lighting, heating, manufacturing and mechanical purposes, in that part of the town of Scarborough in the county of Cumberland which is situate and lies south of the eastern division of the Boston & Maine Railroad, and for an amendment of its charter to include such authority.
