IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THREE.

AN ACT to incorporate the Messalonskee Electric Company.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows :*

Section 1. Harvey D. Eaton, Walter S. Wyman, John N.
2 Webber and Edward L. Meader all of Waterville in the
3 county of Kennebec, their associates, successors and assigns
4 are hereby made a body corporate by the name of the Messa-
5 lonskee Electric Company.

Sect. 2. The purposes of said corporation shall be the mak-
2 ing, generating, selling, distributing and supplying electricity
3 in the city of Waterville and towns of Oakland, Fairfield,
4 Benton and Winslow in accordance with the general statutes

5 relating to that business, except that no right is granted
6 hereby to sell, distribute or supply electricity for lighting
7 purposes in Fairfield, Benton or Winslow.

Sect. 3. The capital stock of said corporation shall be one
2 hundred thousand dollars divided into shares of one hundred
3 dollars each, and it may issue bonds for such amounts as may
4 be required, and secure said bonds by mortgages upon the
5 property and franchises of the company.

Sect. 4. Said corporation is hereby authorized to acquire
2 the plants, property, franchises, rights, privileges and loca-
3 tions of other corporations or individuals engaged in the elec-
4 tric business in the territory above mentioned, and such
5 corporations and individuals are hereby authorized to convey,
6 transfer and assign such plants, property, franchises, rights,
7 privileges and locations to the said Messalonskee Electric
8 Company, and after the acquisition of any such property by
9 said Messalonskee Electric Company, it shall have, hold, enjoy
10 and exercise the same for its own uses and purposes as though
11 originally granted to it.

Sect. 5. This act shall take effect when approved.

MAJORITY REPORT.
