STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THREE.

AN ACT to incorporate the Mt. Abram Cemetery Company.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. Eben E. Rand, Llewellyn P. Bryant, O. P. Far-
2 rington, Walter B. Rand, Charles E. Stowell, Harry M.
3 Swift, their associates, successors and assigns and such other
4 persons as are owners of lots in the cemetery situated at
5 Locke's Mills in the town of Greenwood in the county of
6 Oxford, are hereby created a corporation by the name of the
7 Mt. Abram Cemetery Company.

Sect. 2. The corporation hereby created may purchase and
2 hold such land as may be necessary for the present or future
3 requirements of said corporation not to exceed five thousand
4 dollars and may hold such personal property as may be needed
5 or appropriate to the purposes of this corporation and may

6 convey lots for burial purposes by their corporate deeds, but
7 nothing in this section shall limit the right to take land by
8 petition to the municipal officers of the town in accordance
9 with chapter 15 of the Revised Statutes.

Sect. 3. Said corporation may have a corporate seal to be
2 used in its conveyances and may make and establish such
3 by-laws for the government of its concerns as may be neces-
4 sary, not conflicting with the laws of the State.

Sect. 4. Said corporation by its board of directors shall
2 have the care, control and general management of the cem-
3 etery.

Sect. 5. All persons who are or shall be owners of lots in
2 said cemetery shall be members of this corporation, and each
3 member shall be entitled to one ballot.

Sect. 6. The officers of this corporation shall be a president,
2 secretary, treasurer and a board of directors of not less than
3 five, who shall hold their offices until others are chosen.

Sect. 7. Either of the incorporators is hereby authorized to
2 call the first meeting of the corporation by posting notices
3 thereof in three public places in the vicinity, seven days before
4 said meeting.

Sect. 8. This act shall take effect when approved.
