STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THREE.

AN ACT to change the corporate name of "Maine Wesleyan
Seminary and Female College."

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. The corporate name of the trustees of "Maine
2 Wesleyan Seminary and Female College" as altered and
3 amended by chapters 195 and 310 of the Special Laws of
4 1883 is hereby amended by striking out the word "Female"
5 and inserting in lieu thereof the word 'Woman's,' so that the
6 same shall hereafter be 'Maine Wesleyan Seminary and
7 Woman's College.'

Sect. 2. All donations, gifts, grants, conveyances, devices,
2 and bequests heretofore made to the trustees of the Readfield
3 Religious and Charitable Society; to the trustees of the Maine
4 Wesleyan Seminary; to the trustees of the Maine Wesleyan
5 Seminary and Female Collegiate Institute; to the Maine
6 Wesleyan Seminary and Female College, or that shall here-
7 after be made to either of said corporations or to the trustees
8 thereof, shall be deemed good and valid and shall be and
9 become the property of said "Maine Wesleyan Seminary and
10 Woman's College" as if made to the said seminary and col-
11 lege, or to the trustees thereof, and shall be held by said trus-
12 tees as if made to them, and the said trustees shall have the
13 same right to prosecute in their corporate name any action
14 at law or in equity upon any contract or liability heretofore
15 made or existing with the trustees of the Readfield Religious
16 and Charitable Society; the trustees of the Maine Wesleyan
17 Seminary; the trustees of the Maine Wesleyan Seminary and
18 Female Collegiate Institute; or with the Maine Wesleyan
19 Seminary and Female College, as the said body politic, under
20 whatever name, might have done if the name thereof had not
21 been changed; and also to defend any suit which may be
22 brought against them upon any such contract or liability; and
23 all acts of said trustees in their corporate capacity are hereby
24 ratified.

Sect. 3. This act shall take effect when approved by the
2 governor.
