## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to amend an act incorporating the trustees of Bridgton Academy.

Be it enacted by the Senate and House of Representatives in I cgislature assembled, as follows:

- Section 1. Section 1 of chapter 105 of Laws of Massachu-
- 2 setts of 1808 entitled "An Act to establish an academy at
- 3 Bridgetown in the county of Cumberland," is hereby amended
- 4 by striking out the word "fifteen" and by inserting in lieu
- 5 thereof the word 'twenty,' so that said section as amended
- 6 shall read as follows:
  - 'Sect. 1. Be it enacted by the Senate and House of Repre-
- 8 sentatives, in General Court assembled, and by the authority
- 9 of the same, that an academy shall be, and hereby is estab-

10 lished at Bridgetown, in the county of Cumberland, and that 11 Mr. Samuel Andrews, Mr. Robert Andrews, Mr. Aaron 12 Beman, Stephen Chase, Esq., the Rev. Nathan Church, Mr. 13 David Clark, Doctor Ezra Dean, Samuel Farnsworth, Esq., 14 Mr. Benjamin Kimball, Enoch Perley, Esq., and Mr. Seba 15 Smith, all of said Bridgetown; the Rev. Daniel Gould, of 16 Bethel, the Rev. Lincoln Ripley, of Waterford, Mr. Jonathan 17 Bernard, of , and Mr. Nathaniel Burnham, 18 of Harrison, be, and they are hereby appointed the trustees of 19 the said academy, and they and their successors in the said 20 trust, are hereby made and declared to be a body politic and 21 corporate, by the name of the Trustees of Bridgetown Acad-22 emy; and the said trustees shall have, hold and continue in 23 perpetual succession, with all the powers and privileges 24 usually given to, and exercised and enjoyed by other acad-25 emies: but the number of the said trustees, shall not be less 26 than nine, nor more than twenty, and five of whom may be a 27 quorum for doing business. And the said trustees may keef 28 and use a common seal, which they may alter or change when 29 they see cause; and all deeds or other instruments, made by 30 the said corporation, shall be signed and sealed with their seal, 31 and executed, delivered and acknowledged by the secretary 32 and treasurer of the said corporation, by order of the trustees, 33 and shall be binding on the said corporation, and shall be good 34 and valid in law.'

Sect. 2. This act shall take effect when approved.
