Resolved, That the sum of twenty-five hundred dollars be 2 and hereby is apppropriated for the use of the Maine Chil-3 dren's Home Society, twelve hundred and fifty dollars for 4 the year nineteen hundred and three and twelve hundred and 5 fifty dollars for the year nineteen hundred and four, to aid 6 in maintaining the home of said society for friendless, desti-7 tute and needy children. No part of the above appropriation 8 to be used to pay existing debts.
