## STATE OF MAINE.

### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT relating to bonds to be given by treasurers of towns and plantations.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. The treasurer of each and every town and plan-2 tation, shall, before entering upon the discharge of his official 3 duties, give bond to the inhabitants of his town or plantation, 4 with good and sufficient sureties and for such sum as shall be 5 designated by the municipal officers of his town or planta-6 tion, not exceeding, however, twice the amount of the taxes 7 to be collected during the year for which he is treasurer, 8 conditioned for the faithful discharge of all the duties and 9 obligations of his office. If such bond is not furnished and

10 delivered to the municipal officers, within ten days after writ-11 ten demand by the municipal officers on the treasurer there-12 for, the office of treasurer shall be deemed vacant, and the 13 town or plantation, at any meeting of its inhabitants legally 14 called, may elect a treasurer to fill the vacancy, or the muni-15 cipal officers may fill the vacancy by written appointment 16 which shall be recorded by the town or plantation clerk in 17 the town or plantation records. The municipal officers shall 18 be the sole judges of the sufficiency of such bond and sure-19 ties. Such bond, after its approval and acceptance by the 20 municipal officers, shall be recorded by the town or plantation 21 clerk, and such record shall be prima facie evidence of the 22 contents of such bond, but a failure to so record shall be no 23 defence in any action upon such bond. The municipal offi-24 cers, however, in their discretion, may accept any surety 25 company authorized to do business in the State, as surety on 26 such bond, and dispense with any further surety or sureties 27 thereon. Any town or plantation may lawfully vote, at its 28 annual meeting, to raise money to be expended by its treas-29 urer, under the direction of the municipal officers, for the 30 purpose of purchasing from any surety company authorized 31 to do business as aforesaid, the bond required by this section.

Sect. 2. All acts and parts of acts inconsistent with this 2 act, are hereby repealed.

Sect. 3. This act shall take effect on the first day of June, 2 nineteen hundred and three.
