## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND THREE.

---

AN ACT to amend section one hundred twelve of chapter eleven of the Revised Statutes, as amended by chapter thirty-seven of the Public Laws of eighteen hundred and ninety-one and by chapter one hundred and twenty-one of the Public Laws of eighteen hundred ninety-five and by chapter three hundred eight of the Public Laws of eighteen hundred ninety-seven, relating to Normal Schools and the Madawaska Training School.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. Section one hundred twelve of chapter eleven  
2 of the Revised Statutes, as amended by chapter thirty-seven  
3 of the Public Laws of eighteen hundred and ninety-one and  
4 by chapter one hundred and twenty-one of the Public Laws  
5 of eighteen hundred and ninety-five and by chapter three

6 hundred and eight of the Public Laws of eighteen hundred  
7 and ninety-seven, is hereby further amended by inserting in  
8 place of the word "three" in the first line thereof the word  
9 'four' and in place of the words "thirty-one thousand dollars  
10 is annually appropriated" in the second and third lines of said  
11 section the words 'the sum of thirty-three thousand dollars  
12 is appropriated for the year nineteen hundred three, the sum  
13 of forty thousand dollars for the year nineteen hundred four  
14 and the sum of forty-three thousand dollars annually there-  
15 after,' so that said section as amended by this act shall read  
16 as follows:

'Sect. 112. For the support of the four normal schools and  
18 the Madawaska Training School, the sum of thirty-three  
19 thousand dollars is appropriated for the year nineteen hun-  
20 dred three, the sum of forty thousand dollars for the year  
21 nineteen hundred four and the sum of forty-three thousand  
22 dollars annually thereafter, to be expended under the direc-  
23 tion of said trustees, which sum the treasurer of state shall  
24 deduct for said purpose from any school money raised for the  
25 support of common schools. The governor and council may  
26 from time to time, as they think proper, draw warrants there-  
27 for on said treasurer in favor of said trustees.'

Sect. 2. This act shall take effect when approved.
