STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to amend an act entitled An Act authorizing Washington county to sell its stock in the Washington County Railroad Company, and authorizing the sale or lease of said railroad, approved March 10, 1903.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section one of an act authorizing Washington 2 conuty to sell its stock in the Washington County Railroad 3 Company, and authorizing the sale or lease of said railroad, 4 approved March tenth, nineteen hundred and three, is hereby 5 amended by striking out in the sixteenth and seventeenth lines 6 of said section the words "if said commissioners shall approve 7 said proposition they shall submit it" and inserting in place

8 thereof the words 'said commissioners shall call together the 9 Washington county delegation for the time being to the Maine 10 Legislature and if a majority of said commissioners and dele-11 gation acting jointly shall approve said proposition said com-12 missioners shall submit such proposition,' so that said section, 13 as amended, shall read as follows:

'Sect. 1. Whenever a proposition for the purchase of the 15 holdings of Washington county in the preferred stock of the 16 Washington County Railroad Company shall be made in 17 writing by the holders of the other shares of the stock of said 18 corporation to the county commissioners of said county, or 19 by any other person or corporations said proposition stating 20 in substance that upon a legal transfer of such preferred stock 21 to them, the said holders of the other shares of the stock 22 of said corporation or such other person or corporations as 23 may submit a proposition will pay to said county commis-24 sioners for the use of said county a certain definite sum of 25 money, or when such holders of the other shares of the stock 26 of said corporation or any other person or corporations, shall 27 make any other proposition for the purchase of said preferred 28 stock or the exchange thereof for other securities, said com-29 missioners shall call together the Washington county dele-30 gation for the time being to the Maine Legislature and if a 31 majority of said commissioners and delegation acting jointly 32 shall approve said proposition said commissioners shall sub-33 mit such proposition to the determination of the legal voters 34 of said county at such time as they may designate, subject to 35 the provisions of this act, and thereupon there shall be sub-36 mitted to the voters of the several cities, towns and organized

37 plantations in the county of Washington the following propo-38 sition: "Shall the county commissioners be empowered to 39 dispose of the holdings of the county in the preferred stock of 40 the Washington County Railroad Company in accordance 41 with the written proposition made therefor?" and the war-42 rants issued for calling such meetings shall contain a copy 43 of such written proposition, and it is hereby made the duty 44 of the county commissioners of said county to appoint a day 45 for meetings to vote thereon, and to notify the municipal 46 officers of the cities, towns and plantations thereof, leaving a 47 sufficient time for calling said meetings in the usual form for 48 city or town meetings.

'Said commissioners shall cause to be prepared printed forms 50 for the warrants and returns of said meetings and transmit 51 them with their notifications to city, town and plantation offi-52 cers as above prescribed.'

Sect. 2. Section twelve of said act is hereby amended by 2 inserting at the beginning thereof the words 'After Washing-3 ton county shall have sold its preferred stock in accordance 4 with the provisions of this act'; also by striking out in the 5 eighteenth, nineteenth and twentieth lines the words "and the 6 preferred stock purchased and paid for so the county of 7 Washington is not a holder of said stock," so that said sec-8 tion, as amended, shall read as follows:

Sect. 12. After Washington county shall have sold its pre-10 ferred stock in accordance with the provisions of this act, 11 the Washington County Railroad Company for the purposes 12 hereafter named is hereby authorized to issue its bonds in 13 such amount and with such rate of interest that the annual

14 interest charge thereon shall not exceed the annual interest 15 charge upon the present outstanding mortgage bonds, and to 16 secure the same by a mortgage of its railroad, franchises, 17 property and privileges; provided said mortgage shall be 18 authorized by a majority vote of the holders of the common 19 stock in said company at a legal meeting called therefor, in 20 the call for which the purposes of said meeting shall be stated, 21 and shall also be consented to in writing by the owner or 22 owners of all of the preferred stock in said company. The 23 proceeds of such last named mortgage bonds shall be applied 24 to the payment, redemption or purchase of said first mortgage 25 bonds, or to the purchase of the preferred stock, which when 26 purchased may be retired and cancelled. When all of said 27 bonds shall have been so paid, redeemed or purchased and the 28 first mortgage discharged, any balance remaining may be 29 applied to the improvement or betterment of said road.'

Sect. 3. This act shall take effect when approved.
