STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to authorize the county commissioners of the county of Cumberland to lay out a street in the city of Portland.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section I. The county commissioners of the county of
- 2 Cumberland, if satisfied after notice and hearing that public
- 3 convenience and necessity require it, are hereby authorized
- 4 to lay out a street from some proper point on St. John street
- 5 in the city of Portland thence to and across the Boston and
- 6 Maine Railroad and the Maine Central Railroad to land 7 now held by the Trustees under the will of the late John B.
- 8 Brown, thence across the lands so held to and across the
- 9 location of the Portland and Ogdensburg Railroad and from
- 10 said location to the channel of Fore river, provided, the said

- II Trustees, or their successors in title, shall in writing waive 12 all claim for damages therefor.
 - Sect. 2. If the said county commissioners are, after hear-2 ing, satisfied that public convenience and necessity require 3 the laying out of a highway hereunder, they shall thereupon 4 suspend further proceedings and file their petition with the 5 railroad commissioners for the adjudication required under 6 section twenty-nine of chapter eighteen of the Revised
 - 7 Statutes.
 - Sect. 3. It is hereby made the duty of the municipal offi-
 - 2 cers of the city of Portland, if said street is so laid out across,
 - 3 over or under any railroad track, to make application to the
 - 4 railroad commissioners to determine the manner and con-
 - 5 ditions of crossing the same as is provided in section twenty-
 - 6 seven of chapter eighteen of the Revised Statutes as amended.
 - Sect. 4. All the general laws of the State relative to the
 - 2 laying out, construction and maintenance of highways in
 - 3 incorporated places are hereby made applicable to the street,
 - 4 if any, to be laid out under this act except as herein modified.
 - Sect. 5. This act shall take effect when approved.
