## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND THREE.

---

AN ACT to amend chapter two hundred and twenty-seven of the Private and Special Laws of eighteen hundred and eighty, entitled, "An Act to supply the people of Houlton with pure water," as amended by chapter four hundred and ninety-seven of the Private and Special Laws of eighteen hundred and eighty-nine.

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. Section one of said chapter two hundred and  
2 twenty-seven is hereby amended by adding thereto at the end  
3 of said section the following: 'And for the purpose of pro-  
4 viding the town and village of Houlton a system of public  
5 sewers and drainage, for the comfort, convenience and health  
6 of the people of said Houlton.'

Sect. 2. Section two of said chapter two hundred and  
2 twenty-seven as amended by chapter four hundred and  
3 ninety-seven of the Private and Special Laws of eighteen  
4 hundred and eighty-nine is hereby amended to read as  
5 follows:

‘Said corporation may acquire and hold real and personal  
7 estate, necessary and convenient for the purposes aforesaid,  
8 and the stock in whole or in part of the Houlton Sewerage  
9 Company, not exceeding in all two hundred thousand dollars;  
10 may sell and convey the same; may issue certificates of stock  
11 to an amount not exceeding fifty thousand dollars; and may  
12 issue and sell bonds to an amount not exceeding one hundred  
13 thousand dollars; to aid in the construction, extension,  
14 improvement and repairs of its works, and to pay any exist-  
15 ing debts whether represented by bonds, notes or accounts,  
16 and for the purchase of the whole or any part of the stock  
17 of the Houlton Sewerage Company; and said bonds to the  
18 amount of one hundred thousand dollars may be purchased  
19 and held by the savings banks of Maine.’
