STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THREE.

AN ACT additional to the acts which constitute the charter
of the Trustees of Hebron Academy.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. All acts and doings of the trustees of
2 Hebron Academy in the town of Hebron, county of Ox-
3 ford, in constructing and acquiring a line of poles and
4 wires thereon from Mechanic Falls village in the town of
5 Mechanic Falls, county of Androscoggin, to Hebron
6 Academy in the town of Hebron, aforesaid, for the pur-
7 pose of obtaining electricity for lighting purposes in the

8 buildings and property of Hebron Academy, is hereby
9 approved and declared to be legal and valid, and the con-
10 tract now in force between the trustees of Hebron
11 Academy and the Mechanic Falls Water and Electric
12 Light and Power Company is hereby approved, and the
13 trustees of Hebron Academy are hereby granted the right
14 to maintain said line of poles and wires, for said purposes,
15 between said points, subject to existing provisions of law,
16 and to make and execute additional contract or contracts
17 with said Mechanic Falls Water and Electric Light and
18 Power Company, or any other person or corporation to
19 furnish electricity to be used within said town of Hebron.

Sect. 2. The trustees of Hebron Academy are hereby
2 authorized and empowered to construct and maintain a
3 line of poles and wires thereon, at any point within the
4 town of Hebron, subject to all existing provisions of law
5 or laws hereinafter enacted, regulating the use of elec-
6 tricity, and when said pole line is established, shall have
7 the right to make contracts with persons and corporations
8 for the lighting of streets or buildings within said town
9 of Hebron, and collect and receive such compensation
10 therefor as may be mutually agreed between the parties
11 and may sell or lease their pole lines, franchises and fix-
12 tures belonging to the same, at any time when they deem
13 it for their interest.
