## STATE OF MAINE.

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to incorporate the Hillside Water Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Levi Jones, L. E. Jones, L. B. Jones, E. 2 R. Jones and F. H. Jones, with their associates, successors 3 and assigns, are hereby made a corporation under the name 4 of the Hillside Water Company, for the purpose of supply-5 ing the inhabitants of the town of Winthrop with pure water 6 for domestic and manufacturing purposes, with all the 7 rights and privileges and subject to all the liabilities and 8 obligations of similar corporations under the laws of this 9 state.

Sect. 2. For any of the purposes aforesaid the said cor-2 poration is hereby authorized to take and use water from 3 any springs or wells that they may acquire by purchase of 4 the owner thereof; to conduct and distribute the same into 5 and through said town of Winthrop by pipes or aqueducts 6 in the usual manner.

Sect. 3. The said corporation is hereby authorized to 2 lay, construct and maintain in, under, through, along, 3 over and across the highways, ways, streets and bridges 4 in the said town of Winthrop under such reasonable re-5 strictions as the selectmen of said town may impose, and 6 to take up, replace and repair all such aqueducts, pipes 7 and hydrants and other structures and fixtures as may be 8 necessary and convenient for the said purposes of said cor-9 poration; and the corporation shall be responsible for all 10 damages to the said town and to all corporations, persons 11 and property, occasioned by such use of the said highways, 12 ways and streets. Whenever the said corporation shall lay 13 down or construct any fixtures in any highway, way or 14 street, or make any alterations or repairs upon its works 15 in any highway, way or street, it shall cause the same to 16 be done with as little obstruction to public travel as may 17 be practicable, and shall as its own expense, without unnec-18 essary delay, cause the earth and pavement then removed 19 by it to be replaced in proper condition. The location of

20 all pipes heretofore laid by any of said incorporators for 21 the purposes specified herein are hereby ratified and 22 confirmed.

Sect. 4. The capital stock of the said corporation shall .2 be five thousand dollars, and the stock shall be divided into 3 shares of one hundred dollars each.

Sect. 5. The said corporation for all its said purposes, 2 may hold real and personal estate necessary and convenient 3 therefor, to the amount of five thousand dollars.

Sect. 6. The first meeting of said corporation shall be 2 called by a written notice thereof, signed by any one of the 3 named incorporators, served upon each named incorporator 4 by giving the same in hand or by leaving the same at his 5 last and usual place of abode, at least seven days 6 before the time of meeting, or by mailing such notice, 7 postage paid, to each incorporator directed to his place of 8 residence seven days at least before the time of said meet-9 ing.

Sect. 7. Said corporation may sell all its rights, prop-2 erty and franchises to any other water company in said 3 Winthrop and may buy all the rights, property and fran-4 chises of any other water company in said Winthrop.

Sect. 8. This act shall take effect when approved.
