STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to authorize the Boston Excelsior Company to locate piers and booms in the Sebec river.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. The Boston Excelsior Company, a corporation 2 existing under the laws of the State of Maine, its successors
- 3 and assigns, are hereby authorized and empowered to locate,
- 4 erect and maintain in the Sebec river, opposite the land and
- 5 shore rights of said company in the town of Milo, county of
- 5 Piscataquis, piers and booms for the purpose of collecting
- 7 and holding logs and other lumber coming down said Sebec
- 8 river that belongs to said company. Said piers and booms
- 9 shall be so located, constructed, maintained and used as not
- 10 to impede or to unreasonably obstruct the common use of

11 said Sebec river or to unreasonably delay logs and lumber 12 running down said Sebec river, belonging to other parties 13 and not detained for use and manufacture at the mills of said 14 company, its successors or assigns.

- Sect. 2. Said Boston Excelsior Company, its successors and 2 assigns, by aid of such piers and booms, are hereby authorized 3 and empowered to separate and sort out from the logs and 4 other lumber coming down said Sebec river, all logs, and 5 other lumber destined and intended for use and manufacture 6 at the mills of said company, and said company is also hereby 7 authorized and empowered to hold within the piers and booms 8 mentioned in this act and located, erected and maintained as 9 aforesaid, all logs and other lumber coming down said Sebec 10 river which are destined and intended for use and man-11 ufacture at the mills of said company, erected upon said 2 Sebec river.
- Sect. 3. The organization of the Boston Excelsior Com-2 pany under the general laws of the State of Maine, and the 3 acts, doings and votes of said company at the annual meeting 4 of its stockholders on the last Tuesday of January in the 5 year 1902, enlarging the purposes of its organization are 6 hereby ratified, conferred and made valid.
- Section 4. Said Boston Excelsior Company is hereby 2 authorized and empowered to issue its bonds for the purpose 3 of its business on such rates and time as it may deem expedite 4 ent and to secure the payment of the principal and interest 5 on such bonds by appropriate mortgages or deeds of trust or 6 any part of its property, franchises, rights and privileges now 7 owned or to be hereafter acquired by it.
 - Sect. 5. This act shall take effect when approved.
