STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THREE.

AN ACT to correct clerical errors and make plain the meaning of and amend chapter 30 of the Revised Statutes, as amended by chapter 42 of the Public Laws of 1899, and as amended by chapters 222 and 278 of the Public Laws of 1901, and chapter 326 of the Private and Special Laws of 1901, and acts reported from the committee on inland fisheries and game relating to inland fisheries and game.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section 5 of chapter 30 of the Revised Statutes,

- 2 as amended by chapter 42 of the Public Laws of 1899, is
- 3 hereby amended in the first fourteen lines of the same as fol-
- 4 lows: By inserting the word 'land' before the word "locked"
- 5 in the third line of said section, and by inserting the words
- 6 'or have the same in possession' after the word "state" in the

7 fourteenth line of said section, so that the first fourteen lines 8 of said section, as amended, shall read as follows:

'Sect. 5. There shall be an annual close time for landlocked salmon, trout, togue and white perch, as follows: for land11 locked salmon, trout and togue, from the first day of October 12 until the ice is out of the pond, lake or river fished in the 13 following spring of each year, except on the St. Croix river 14 and its tributaries, and on all the waters of Kennebec county, 15 in which the close time shall be from the fifteenth day of 16 September until the ice is out of the ponds and lakes the 17 following spring, and in Franklin county in which the close 18 time shall be from the first day of October till May first; but 19 for white perch, the close time shall be from the first day of 20 April to the first day of July; no person shall take, catch, kill 21 or fish for in any manner any landlocked salmon, trout, togue 22 or white perch in any of the waters of this State or have the 23 same in possession, in close time.'

Sect. 2. So much of chapter 30 of the Revised Statutes, 2 as amended by chapter 42, section 5, of the Public Laws of 3 1899, as closes Greely brook and tributaries, situated partly 4 in the towns of Oxford and Norway in the county of Oxford 5 and in the town of Otisfield in the county of Cumberland, is 6 hereby repealed.

Sect. 3. Section 22 of chapter 30 of the Revised Statutes, 2 as amended by chapter 42 of the Public Laws of 1899, and 3 as amended by chapter 222 of the Public Laws of 1901, is 4 hereby amended so as to read as follows:

'Sect. 22. The words "close season" and "close time" where 6 used in this act, shall mean the time or period during which 7 by this act it is made unlawful to hunt, shoot, wound, trap, 8 or destroy any bird or animal, or fish for, or catch any fish 9 mentioned or referred to in this act, and the words "open 10 season" where used in this act, shall mean the time or period 11 during which it shall be lawful to take these animals, fish and

12 birds as specified and limited. Any person may, at any time, 13 lawfully kill any dog which hunts or chases a moose, caribou 14 or deer, or any dog kept or used for that purpose. Any •15 person owning or having in his possession any dog for the 16 purpose of hunting or chasing moose, caribou or deer, or who 17 permits any dog owned by him or in his possession to hunt or 18 chase caribou, deer or moose, after notice that such dog has 19 chased moose, caribou or deer, shall be punished by a fine of 20 one hundred dollars and costs of prosecution for each offense. 21 Sunday is a close time, on which it is not lawful to hunt, kill 22 or destroy game or birds of any kind, under the penalties 23 imposed therefor during other close time; but the penalties 24 already imposed for the violation of the Sunday laws by the 25 Statutes of this State are not hereby repealed or diminished.'

Sect. 4. Section 21 of chapter 30 of the Revised Statutes, 2 as amended by chapter 42 of the Public Laws of 1899, and 3 as amended by chapter 278 of the Public Laws of 1901, is 4 hereby amended as follows: by striking out all of said section between the word "November" in the sixth line of said 6 section and the word "any" in the thirteenth line of said section, and inserting instead thereof the words, 'and no registered guide shall guide at the same time, or be employed by 9 at the same time, more than five non-residents for hunting,' 10 so that said section as amended shall read as follows:

'Sect. 21. It shall be unlawful for non-residents of the State to enter upon the wild lands of the State with intent to 13 camp and kindle fires thereon, while engaged in hunting or 14 fishing, without being in charge of a registered guide during 15 the months of May, June, July, August, September, October, 16 and November; and no registered guide shall guide at the 17 same time, or be employed by at the same time, more than 18 five non-residents for hunting. Any such non-resident who 19 shall take, catch, or kill any deer, or enter upon the wild lands

20 in this State, with intent to camp, and kindle fires thereon, 21 while engaged in hunting or fishing, without being in charge 22 of a registered guide, during the months of May, June, July, 23 August, September, October and November, in violation of⁴ 24 the provisions herein contained, shall be fined forty dollars 25 and costs of prosecution for each offense and be subject to 26 imprisonment thirty days.'
