IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND THREE.

AN ACT to ratify the lease of the Sangerville Improvement  
Company to the Dover and Foxcroft Light and Heat Com-  
pany.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. The proceedings of the incorporation and organ-  
2 ization of the Sangerville Improvement Company are hereby  
3 confirmed and made valid, and all the proceedings of said  
4 corporation in calling, holding and acting in a meeting of  
5 said corporation held at Dover, in the county of Piscataquis,  
6 at the office of Frank E. Guernsey, on the twenty-seventh  
7 day of September, A. D. 1902, and all the proceedings of said  
8 corporation in calling, holding and acting in a meeting of

9 said corporation, held at Sangerville in said county on the  
10 ninth day of October, A. D. 1902, and all the votes, acts and  
11 doings of said corporation at said meeting are hereby ratified,  
12 confirmed and made valid.

Sect. 2. The existing lease of date of October ninth, A. D.  
2 1902, between said Sangerville Improvement Company and  
3 Dover & Foxcroft Light and Heat Company is hereby ratified,  
4 confirmed and made valid.

Sect. 3. The Dover & Foxcroft Light and Heat Company  
2 is authorized and empowered, as lessee, or in case of purchase  
3 of the plant, property and franchise of the Sangerville  
4 Improvement Company, to supply the town of Sangerville  
5 and the inhabitants thereof with light, heat and power by the  
6 manufacture of electricity.

Sect. 4. The town of Sangerville is hereby authorized to  
2 enter into a contract with the Dover & Foxcroft Light and  
3 Heat Company for street lighting for a term of years.

Sect. 5. The Sangerville Improvement Company is hereby  
2 authorized to sell and the Dover & Foxcroft Light and Heat  
3 Company to buy the plant, property and franchise, and all the  
4 rights and privileges of the Sangerville Improvement Com-  
5 pany in its corporate capacity in accordance with the terms of  
6 the lease mentioned in section two of this act, or at any time  
7 that said Sangerville Improvement Company may agree, to  
8 sell its plant, property, franchise and corporate rights to said  
9 Dover & Foxcroft Light and Heat Company during the term  
10 of said lease as well as at the time specified in said lease that  
11 said sale or purchase may take place.

Sect. 6. This act shall take effect when approved.
