IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND THREE.

AN ACT to amend section 3 of chapter 258 of the Public Laws  
of 1893, relating to school funds derived from Savings Bank  
Tax.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. That section three of chapter 258 of the Public  
2 Laws of 1893, be amended by striking out in the third line,  
3 the words "one-half," and inserting the words, 'five-eighths,'  
4 and also striking out in the sixth line the words "one-half"  
5 and inserting the words 'three-eighths,' so that said section  
6 as amended shall read as follows:

'All taxes so assessed shall be paid semi-annually within ten  
8 days after the fifteenth days of June and December. Five-  
9 eighths of the sum so paid shall be appropriated for schools,

10 in the manner provided for tax on banks of circulation in  
11 section one hundred seventeen of chapter eleven of the Re-  
12 visd Statutes, and three-ighths to th' stat.

### MAJORITY REPORT.
