STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND FIVE.

AN ACT to incorporate the Trinitarian Congregational Parish of Castine, and to legalize the doings of said parish as heretofore known under the name of the Trinitarian Society of Castine, Maine.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Robert G. Harbutt, Thomas E. Hale, Albert F. 2 Richardson, Edward E. Philbrook, Hattie Philbrook, Frank 3 V. Grindle, Helen Grindle, Alice Grindle, William A. Walker, 4 Thomas E. Devereux, Harriet S. Devereux, Pauline Faye 8 Devereux, Alfred F. Adams, Mary Williams, Julian Webber,

9 Ellen Brophy, Ethel Noyes, Freeman Stover, Elsie Stover
10 and Eleanor Stover, all of Castine, in the county of Hancock,
11 and State of Maine, their associates and successors, are
12 hereby constituted a body corporate by the name of the Trini-
13 tarian Congregational Parish of Castine, and as such may
14 take by gift or purchase any real or personal estate to be
15 held and used for church purposes, and convey the same, and
16 may establish by-laws not repugnant to law.

Sect. 2. All past acts and doings of said parish as hereto-
2 fore known by the name of the Trinitarian Society of Cas-
3 tine, or any other name, are hereby legalized.

Sect. 3. Any one of the above named members may call
2 the first meeting of said corporation by mailing a written
3 notice signed by him or her, postage paid, to each of the
4 other members, seven days at least before the day of meeting,
5 naming the time, place and purpose of such meeting, and at
6 such meeting a clerk and other needful parish officers may
7 be chosen, by-laws adopted, and any other corporate business
8 transacted. Subsequent meetings shall be called and held in
9 accordance with the provisions of section four of chapter
10 sixteen of the Revised Statutes, and said corporation shall in
11 all respects, after the first meeting, be governed by the stat-
12 ute applicable to parishes and religious societies.

Sect. 4. This act shall take effect when approved.
