IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND FIVE.

AN ACT additional to and amendatory of chapter 137 of the Private and Special Laws of nineteen hundred and three, entitled "An Act to amend the charter of the city of Auburn and to provide for a Board of Public Works."

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. That section two of said chapter 137 be amended 2 by striking out the word "five" in the first line, and inserting 3 in place thereof the word 'six,' and adding at the end of the 4 section: "The mayor of the city for the time being shall be 5 ex-officio a member of the Board of Public Works, and shall 6 be chairman thereof,' so that said section as amended shall 7 read as follows:

'Sect. 2. This board shall consist of six members, one from 9 each ward, who shall be elected by the city council in the 10 month of March. The mayor of the city for the time being

11 shall be ex-officio a member of the Board of Public Works,  
12 and shall be chairman thereof.'

Sect. 2. That section four of the said chapter be amended  
2 by inserting after the word "eligible" in the first line the  
3 words 'to election,' so that said section as amended shall read  
4 as follows:

'Sect. 4. No member of the city council shall be eligible to  
6 election for service upon this board.'

Sect. 3. That section five be amended by striking out in  
2 the second and third lines these words, "one of its members  
3 as chairman and shall elect," so that said section as amended  
4 shall read as follows:

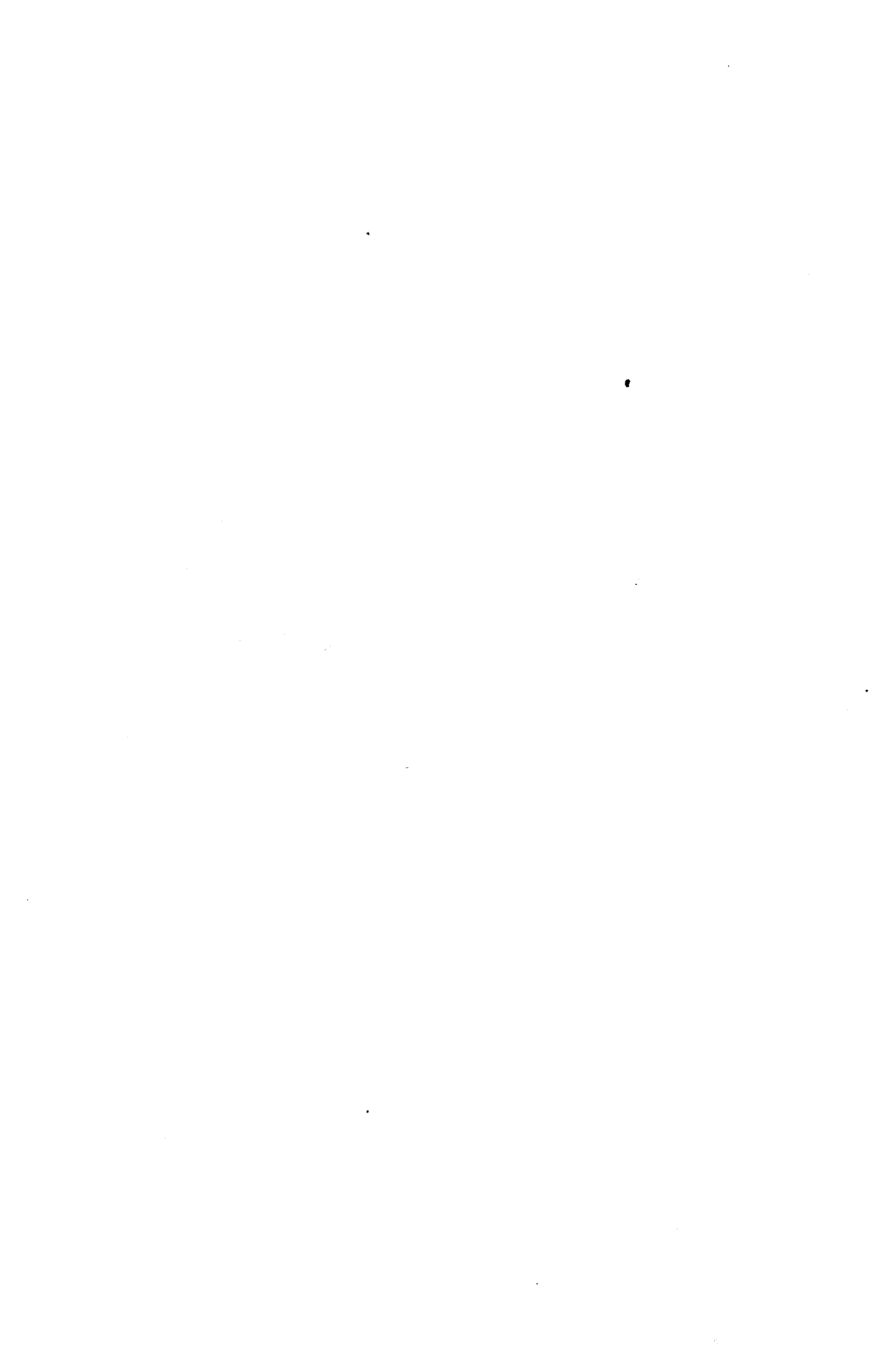
'Sect. 5. This board shall on the third Monday in March  
6 or as soon thereafter as practicable organize by the choice of  
7 a secretary whose duty it shall be to keep a record of the  
8 proceedings of the board, to notify members of meetings and  
9 perform such other duties as the board may direct.'

Sect. 4. That section seven be amended so it shall read as  
2 follows:

'Sect. 7. The weekly pay roll shall be approved by the  
4 superintendent of streets and sewers, and by the chairman  
5 of the board or in his absence by some member designated  
6 by him, all other bills shall be passed upon by the board before  
7 being paid from the city treasury.'

Sect. 5. All acts or parts of acts inconsistent with the pro-  
2 visions of this act are hereby repealed.

Sect. 6. This act shall take effect when accepted by the  
2 city council of the city of Auburn.
