STATE OF MAINE.

RESOLVE in favor of aid in building a highway bridge across the Kennebec river between the towns of Bingham and Concord.

Resolved, That the sum of twenty thousand dollars, to be
2 paid, ten thousand dollars in the year nineteen hundred and
3 five and ten thousand dollars in the year nineteen hundred
4 and six, be and hereby is appropriated from any unexpended
5 moneys in the treasury to aid in building a highway bridge
6 across the Kennebec river between the towns of Bingham
7 and Concord in the county of Somerset.

Provided, the sum of five thousand dollars be raised by said
9 county and the necessary balance by the towns of Bingham
10 and Concord, or otherwise, which, together with the amount
11 herein appropriated, shall be sufficient to fully complete said
12 bridge, within two years from the date of the approval of
13 this resolve without further aid from the State. And said

14 county is hereby authorized and required to raise the sum
15 herein provided for it to raise, by taxation or otherwise,
16 within two years from the date of the approval of this act;
17 and said towns are hereby authorized to raise, by taxation
18 or otherwise, any sums which may be necessary for them, or
19 either of them, to raise to carry out the provisions of this
20 act.

Provided also, that the location and erection of said bridge
22 shall be under the supervision of the county commissioners
23 of Somerset county. Said bridge shall be built of steel or
24 iron not less than eighteen feet wide upon stone piers and
25 abutments, upon plans of a competent bridge engineer, to be
26 approved by the governor and council, and said bridge shall
27 be completed, opened to the public and accepted by the gov-
28 ernor and council before the last installment, above provided
29 for, to be paid by the State, shall be paid. All moneys under
30 this resolve shall be paid upon vouchers satisfactory to the
31 governor and council.

Provided further, that said bridge shall be kept in repair at
33 the expense of the towns of Bingham and Concord in pro-
34 portion to their respective valuations as fixed, from time to
35 time, by the State assessors.

Provided also, that said bridge shall be built on the basis of
37 a cost of thirty-five thousand dollars, and that the amount
38 paid by the State under this resolve shall not exceed four-
39 sevenths of the cost.

Provided also, that the actual damages sustained by the
41 owner of the ferry at this place caused by the building of
42 this bridge, shall be appraised by the county commissioners
43 of Somerset county, the same to be paid by said county.
