STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIVE.

AN ACT to extend and amend the charter of the Waterville and Winslow Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. The time within which the Waterville and
- 2 Winslow Bridge Company, incorporated under chapter two
- 3 hundred and sixty-five of the Private and Special Laws for
- 4 nineteen hundred and three, is required to commence actual
- 5 business, is hereby extended for two years from the approval 6 of this act.
- Sect. 2. Section two of said chapter is hereby amended so 2 as to read as follows:
- 'Sect. 2. The capital stock of said corporation shall not
- 4 exceed one hundred and fifty thousand dollars, to be fixed
- 5 from time to time by the corporation.'

- Sect. 3. Said corporation is hereby authorized to erect, 2 maintain and operate manufacturing establishments, and to 3 own and operate sailing or steam vessels. The right of emi-4 nent domain authorized by its charter shall not be exercised 5 by said company for any of the purposes of this section.
- Sect. 4. In the erection and maintenance of the bridge 2 authorized by its said charter said company is authorized to 3 so build and maintain the same that it will also be suitable 4 for teams, foot passengers, and electric cars. The said corporation, its successors and assigns, may make all necessary 6 contracts with street railroad companies for their appropriate 7 use thereof, and such street railroad companies are hereby 8 authorized to enter into such contracts. It may also contract 9 from time to time with the city of Waterville and the town 10 of Winslow, or either of them, for the public use of that por-11 tion of said bridge suitable for teams and foot passengers.

 12 Said city and town may execute such contracts through their 13 municipal officers hereby authorized so to do, and moneys 14 may be raised and appropriated therefor as for other neces-15 sary town charges.
 - Sect. 5. Section six of said charter is hereby amended so 2 as to read as follows:
 - 'Sect. 6. The first meeting of said corporators shall be 4 called by either of them by notice by him signed, given in 5 hand or mailed, postage prepaid, to the others, at least seven 6 days before such meeting. Any corporator may act at said 7 meeting by proxy.'
 - Sect. 6. This act shall take effect only when the directors 2 of the Wiscasset, Waterville and Farmington Railroad Com-

- 3 pany, its successors and assigns, shall file a written assent
- 4 hereto in the office of the secretary of state, and to empower
- 5 the filing of such assent it shall take effect when approved by
- 6 the governor.
