STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIVE.

AN ACT to amend section sixteen of chapter twenty-four of the Revised Statutes relating to the law of the road.

Be it enacted by the Scnate and House of Representatives in Legislature assembled, as follows:

- Section I. Section sixteen of chapter twenty-four of the
- 2 Revised Statutes is hereby amended by inserting after the
- 3 word "Abbot" in the eighth line thereof the following: 'and
- 4 when traveling on the road leading from West Buxton in
- 5 Buxton in York county to the Saco River railroad station and
- 6 on the road leading from said West Buxton to the Buxton
- 7 railroad station and on the road leading from Bar Mills in
- 8 Buxton via Duck pond, so called, to the Gorham town line,'
- 9 so that said section as amended shall read as follows:

Teams with wheels, if drawn by more than two 11 horses, oxen or mules, must have the rims of their wheels at 12 least four inches wide, and if drawn by more than four 13 horses, oxen or mules, at least five inches wide, when travel-14 ing on the road from Jackson Brook, in Washington county, 15 to Forest City, and when traveling on the highway from the 16 spool mill of the Willimantic Linen Company, in Willimantic, 17 in Piscataguis county, by the residences of Irvine Floyd or 18 Jabez Hathaway, to Francis' siding on the Bangor and 19 Aroostook railroad in Abbot, and when traveling on the road 20 leading from West Buxton in Buxton in York county to the 21 Saco River railroad station and on the road leading from said 22 West Buxton to the Buxton railroad station and on the road 23 leading from Bar Mills in Buxton via Duck pond, so called, 24 to the Gorham town line; and no team drawn by more than 25 six horses, oxen or mules, shall travel thereon. This section 26 is not applicable to stage or pleasure carriages, or to those 27 owned by the State or the United States, or to any cart or 28 wagon owned by the settlers in the vicinity and used for 29 farming purposes. The owner or driver of a team violating 30 this section, forfeits twenty dollars and one dollar more for 31 each mile of road passed, to be recovered by complaint before 32 a municipal or police court or trial justice in the county where 33 the offense was committed, and on a libel or complaint, he 34 may issue his warrant to seize and detain such team to 35 respond to such fine and cost.'
