# SEVENTY-SECOND LEGISLATURE

## STATE OF MAINE.

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIVE.

AN ACT to amend section 22 of chapter 6 of the Revised Statutes relating to the better arrangement of shelves in the polling places.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. That section 22 of chapter 6 be amended by 2 striking out in the second sentence, and substituting in its 3 place the following:

'The arrangement shall be such that the voting shelves or 5 compartments shall not be less than one and one-half feet 6 from the floor, and the top of the same not more than five 7 feet from the floor, and so placed as to be hidden from the 8 view of all persons not participating in voting; and it is also

9 provided that, there shall be inside the guard rail, and in view 10 of all others, a voting shelf or compartment for the exclusive 11 use of voters who require the assistance of election clerks in 12 marking their ballot. The ballot boxes shall not be hidden 13 from the view of persons outside the guard rail.'

Section 2. So that the section shall read:

'The municipal officers of each city, town or plantation, as 3 aforesaid, shall cause the polling places therein to be suitably 4 provided with a sufficient number of voting shelves or com-5 partments, at or in which voters may conveniently mark their 6 ballots, so that in the marking thereof they shall be screened 7 from the observation of others and a guard rail shall be so 8 constructed and placed that only such persons as are inside 9 said rail can approach within six feet of the ballot boxes, and 10 of such voting shelves or compartments. The arrangement II of said voting shelves shall be such that there shall be an 12 open space of at least one ane one-half feet between voting 13 shelf and floor, (uninclosed) and the top of the same not 14 more than five feet from the floor, and so placed as to be 15 hidden from the view of all persons not participating in 16 voting; and it is also provided, that there shall be inside the 17 guard rail, and in view of all others, a voting shelf or com-18 partment for the exclusive use of all voters who require the 19 assistance of election clerks in marking their ballots. The 20 ballot boxes shall not be hidden from the view of persons 21 outside the guard rail. The number of such voting shelves 22 or compartments shall not be less than one for every one 23 hundred voters qualified to vote at such polling place, and 24 not less than three in any town, and not less than five in any 25 ward of a city. No persons other than the election officers, 26 election clerks and voters admitted, as hereinafter provided, 27 shall be permitted with said rail, except by the authority of 28 the presiding election officer or officers for the purpose of 29 keeping order and enforcing the law. Each voting shelf or 30 compartment shall be kept provided with proper supplies and 31 conveniences for marking ballots.'
