## STATE OF MAINE.

RESOLVE laying a tax on counties of the State for the years nineteen hundred and five and nineteen hundred and six.

*Resolved*, That the sum annexed to the counties in the 2 following schedule is hereby granted as a tax on each county 3 respectively to be appropriated, assessed, collected and 4 applied to the purposes of paying the debts and necessary 5 expenses of the same and for other purposes of law. For 6 the year one thousand nine hundred and five:
