STATE OF MAINE.

RESOLVE in favor of the Maine General Hospital.

Resolved, That there be and hereby is appropriated the sum

- 2 of seventy-five hundred dollars, (\$7,500) to be paid to the
- 3 Maine General Hospital for the use of said institution for the
- 4 year 1905, and seventy-five hundred dollars (\$7,500) to be
- 5 paid to said institution for its use for the year 1906.

Be it further resolved that there be and hereby is appro-

- 7 priated the further sum of \$1,000 for the year 1905, and
- 8 \$1,000 for the year 1906, for repairs.

STATEMENT OF FACTS.

To the Honorable Senate and House of Representatives of Maine:

The Maine General Hospital again makes its appeal as a charitable institution to your consideration and submits herewith a brief statement showing how the appropriations made by the legislature two years ago have been expended and what the hospital's present needs are.

During the past year 334 absolutely free patients have received treatment and 112 more have paid board in part only. Multiplying the number of free patients by the number of weeks' board furnished each and the total number of weeks of free service is 2,031. The daily average of free patients during the year was 38.95.

There was received from the paying patients the sum of \$3,528.75 above the cost of their maintenance. If the number of weeks of absolutely free treatment furnished be multiplied by the average weekly cost of maintenance, \$12.53, the total amount expended for free service was \$25,448.43.

All the available income of the hospital was used in furnishing free service as follows:

It thus appears that owing to the large amount of free treatment to worthy poor patients there was expended a sum in excess of the income of the hospital. This is the fourth deficit that has been incurred.

In all the above years the paying patients yielded something more than their cost. The deficits are due to free service, the coal strike and the high prices of food. The annual income must be increased or free service must be curtailed. Already all unrestricted funds are exhausted and no resources are at hand for making up past shortages.

In the summer of 1901 the construction of a nurses' home, made necessary by the crowded condition of the hospital, was begun. Rooms that should have been devoted to patients were occupied by nurses and one ward could not be opened for lack of a sufficient nursing force. The new building was finished the following year at a total cost of \$45,404.23, of which \$38,355 was met by special subscription by friends of the hospital. Following the nurses' home, it became necessary to replace our surgery with one of modern construction which has been done at a cost of \$35,697.59. At present extensive alterations and enlargements of the kitchen are in progress, in order that the increased number of patients may be supplied with properly pre-This improvement will involve an pared and cooked food. expense estimated at \$6,000. About fifty thousand dollars of the hospital's funds have during the last four years been spent . and are now being spent to bring the plant up to the proper requirements. Since 1885 when \$2,500 was granted, no appropriation for construction has been made by the State and it is to pay in part for the large outlays already made, as well as for those now being made and required in future, that the legislature is asked to make an extra appropriation of \$20,000 for hospital construction. An isolated ward for contagious cases should be constructed without further delay and certain renewals in the older buildings should be begun but the hospital is without

means for further expenditures and is in debt to pay for work now going on.
