#### STATE OF MAINE.

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIVE.

AN ACT to amend sections 100 and 102 of chapter 23 of the Revised Statutes, relating to State Roads.

### Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section one hundred of chapter twenty-three of

- 2 the Revised Statutes is hereby amended by striking out the
- 3 word "two" in the fourth line thereof and inserting the word
- 4 'three' in its place, and by striking out in the fifth line thereof
- 5 the words "appropriation and," so that said section as
- 6 amended shall read as follows:

'Sect. 100. Towns establishing State roads as aforesaid 8 may, on complying with the conditions hereinafter set forth,

9 receive from the State one half of the amount actually 10 expended in permanent improvement of said roads, not 11 exceeding three hundred dollars a year; provided, that no 12 town shall receive such State aid unless its expenditure for 13 such road shall amount to at least one hundred dollars, and 14 shall have been exclusive of and in addition to the amount 15 regularly raised in such town for highways and bridges; and 16 provided, also, that the amount so expended shall be used 17 before the first day of September in permanent improvement 18 of a portion of said road, and in a manner satisfactory to 19 the county commissioners of the county wherein said road 20 is located. Such aid shall be paid from the State treasury 21 on and after the first day of January, upon certificate by the 22 governor and council, as provided by the following section.'

Sect. 2. Section one hundred and two of chapter twenty-2 three of the Revised Statutes is hereby amended by striking 3 out all after the fourth line thereof, so that said section as 4 amended shall read as follows:

"Sect. 102. Towns desiring to take advantage of the pro-6 visions of sections ninety-nine to one hundred and five, inclu-7 sive, may, through their municipal officers, make application 8 therefor to the secretary of State, and he shall record such 9 applications in the order in which they are received.'

Sect. 3. Section one hundred and four of chapter twenty2 three of the Revised Statutes is hereby repealed.

Sect. 4. This act shall take effect when approved.
