*Resolved,* That the sum of two hundred and seventy-three  
2 dollars and seventy-nine cents (\$273.79) be and the same  
3 hereby is appropriated to re-imburse the town of Chelsea,  
4 in the county of Kennebec and State of Maine, for money  
5 expended by it during the years of 1903 and 1904 in furnish-  
6 ing pauper supplies to Ida Drake.
