IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND FIVE.

AN ACT to establish a law uniform with other states relative  
to Insurance Policies.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. No policy of insurance shall be rendered invalid  
2 by reason of any statement, representation or warranty made  
3 by the insured unless the same shall be material to the risk  
4 or made with intent to defraud.

Sect. 2. This act shall apply to all certificates of fraternal  
2 and mutual benefit as well as to all other forms of insurance.

Sect. 3. All acts and parts of acts inconsistent herewith  
2 are hereby repealed.

The Committee on Merchantile Affairs and Insurance to which was referred the bill entitled "An Act to establish a law uniform with other states relative to insurance policies," have had the same under consideration, and ask leave to report the same in a new draft, under the title of "An Act to establish a law uniform with other states relative to insurance policies" and that it ought to pass.

AN ACT to establish a law uniform with other states relative  
to Insurance Policies.

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. No policy of insurance shall be rendered invalid  
2 by reason of any statement, representation or warranty made  
3 by the insured unless the same shall be material to the risk  
4 or made with intent to defraud.

Sect. 2. No policy of insurance shall contain any condition,  
2 provision or agreement which shall, directly or indirectly,  
3 deprive the insured or the beneficiary of the right of trial by  
4 jury on any question of facts arising under said policy and  
5 all such conditions, provisions or agreement shall be void.

Sect. 3. This act shall apply to certificates of fraternal and  
2 mutual benefit as well as to all other forms of insurance.

Sect. 4. All acts and parts of acts inconsistent herewith  
2 are hereby repealed.

The Committee on Merchantile Affairs and Insurance to which was referred the bill entitled "An Act to establish a law uniform with other states relative to insurance policies," have had the same under consideration and ask leave to report that the same ought to pass.
