STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIVE.

AN ACT in relation to the taxation of mortgages on real estate.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section five of chapter nine of the Revised Stat-

- 2 utes is hereby amended by inserting after the word "owing"
- 3 in the fourth line of said section, the following words: 'but
- 4 not including in such debts due them or indebtedness from
- 5 them any loan on mortgage of real estate situated in this
- 6 State, except the excess of such loan above the assessed value
- 7 of the mortgaged real estate.' So that said section as
- 8 amended shall read as follows:

'Sect. 5. Personal estate for the purposes of taxation, to includes all goods, chattels, moneys and effects, wheresoever

11 they are; all vessels, at home or abroad; all obligations for 12 money or other property; money at interest, and debts due 13 the persons to be taxed more than they are owing; but not 14 including in such debts due them or indebtedness from them 15 any loan on mortgage of real estate, situated in this State, 16 except the excess of such loan above the assessed value of the 17 mortgaged real estate; all public stock and securities; all 18 shares in moneyed and other corporations within or without 19 the State, except as otherwise provided by law; all annuities 20 payable to the person to be taxed when the capital of such 21 annuity is not taxed in this State; and all other property, 22 included in the last preceding State valuation for the pur-23 poses of taxation.'

Sect. 2. This act shall take effect when approved.
