## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND FIVE.

---

AN ACT to authorize the Sanford Light and Power Company to increase its capital stock, and to acquire and purchase the rights of the Atlantic Shore Line Railway to furnish electric light, heat and power in the town of Sanford.

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. Section 3 of chapter 186 of the Private and  
2 Special Laws of 1903 is hereby amended by striking out the  
3 word "fifty" in the first line of said section, and inserting in  
4 lieu thereof, the words, 'one hundred,' so that said section as  
5 amended shall read as follows:

‘Section 3. The capital stock of said corporation shall be  
7 one hundred thousand dollars, divided into shares of one  
8 hundred dollars each.’

Sect. 2. The Sanford Light and Power Company is hereby  
2 authorized to acquire by purchase or otherwise, the franchise  
3 and rights of the Atlantic Shore Line Railway to furnish  
4 electric light, heat and power in the town of Sanford, and  
5 said Atlantic Shore Line Railway is hereby authorized to sell  
6 and convey, or otherwise transfer to said Sanford Light and  
7 Power Company its franchise and rights to furnish electric  
8 light, heat and power in the town of Sanford, and all acts,  
9 transactions and contracts relating thereto, heretofore and  
10 hereafter, entered into by and between said corporations are  
11 hereby ratified and confirmed; provided nevertheless, that  
12 nothing herein contained shall prevent said Atlantic Shore  
13 Line Railway from furnishing electricity for light, heat and  
14 power to Sanford Mills, Goodall Worsted Company, and  
15 Maine Alpaca Company, only, corporations in said town of  
16 Sanford; and provided further, that said Atlantic Shore Line  
17 Railway and its constituent companies, viz: Mousam River  
18 Railroad, Sanford and Cape Porpoise Railway Company, and  
19 Sanford Power Company, shall not furnish electricity for  
20 light, heat or power to any person or corporation in said  
21 Sanford other than said Sanford Mills, Goodall Worsted  
22 Company, and Maine Alpaca Company.

Sect. 3. This act shall take effect when approved.
