STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND FIVE.

AN ACT to amend chapter one hundred thirty of the Private Laws of eighteen hundred and sixty-six, entitled "An Act to incorporate the Sebec Dam Company," as amended by section six of chapter twenty-six of the Private and Special Laws of eighteen hundred and ninety-nine, and further amended by chapter one hundred and forty-one of the Private and Special Laws of nineteen hundred and three.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

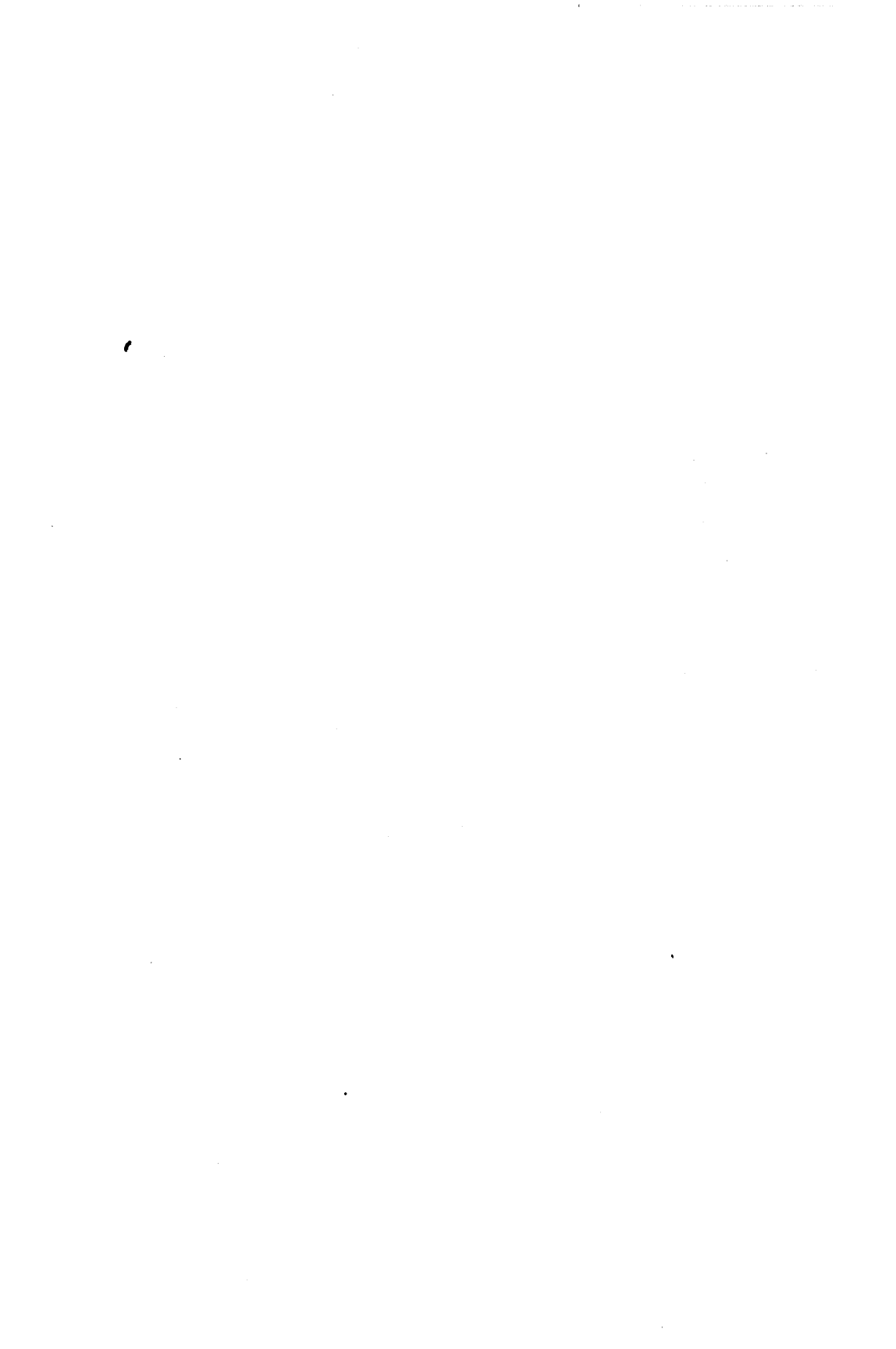
Section 1. Chapter one hundred and thirty of the Private
2 and Special Laws of eighteen hundred and sixty-six, as
3 amended by chapter twenty-six of Private Laws of eighteen

4 hundred ninety-nine, as amended by chapter one hundred
5 forty-one of the Private Laws of nineteen hundred three, is
6 hereby further amended by adding the following section:

'Sect. 7. All the gates of said dam shall be kept tightly
8 closed from the first day of March to the first day of July
9 in each year. And during said period of time, from the first
10 of March to the first day of July in each year, none of said
11 gates shall be hoisted except when necessary for log driving
12 and manufacturing purposes on Sebec river as specified in
13 said chapter and amendments, but whenever during the
14 period aforesaid the waters of Sebec lake shall be needed
15 for said purposes or at any time for manufacturing including
16 power purposes on the several privileges of Sebec river said
17 gates shall be hoisted to the extent required to allow the
18 escape of sufficient water therefor.

Sect. 8. The county commissioners of Piscataquis county
20 on petition of any person having property rights affected,
21 or which may be affected, under the provisions of the fore-
22 going section, may appoint a resident of said county an agent
23 who shall have the management of the gates in the dam of
24 the Sebec Dam Company for such time as said commissioners
25 may determine and such agent shall receive for his services
26 three dollars a day, one-half to be paid by said petitioner and
27 one-half by said Dam Company. The fees of said commis-
28 sioners shall be paid by the petitioner.'

Sect. 2. This act shall take effect when approved.
