STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND FIVE.

AN ACT relating to the compensation of clerks of courts.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. The clerks of the judicial courts in the several
2 counties shall receive annual salaries from the treasuries of
3 the counties in quarterly payments on the first days of Janu-
4 ary, April, July and October, as follows:
5 Androscoggin, two thousand dollars.
6 Aroostook, two thousand dollars, with eight hundred dollars
7 additional for clerk hire.
8 Cumberland, two thousand two hundred dollars, with twelve
9 hundred dollars a year additional for clerk hire; assistant
10 clerk of courts, twelve hundred dollars.
11 Franklin, eleven hundred dollars.
12 Hancock, two thousand one hundred dollars, with three hun-
13 dred dollars additional for clerk hire.

- 14 Kennebec, two thousand two hundred dollars, with eight hun-
15 dred dollars additional for clerk hire.
16 Knox, thirteen hundred dollars.
17 Lincoln, one thousand dollars.
18 Oxford, one thousand dollars.
19 Penobscot, two thousand dollars, with eight hundred dollars
20 additional for clerk hire.
21 Piscataquis, one thousand dollars.
22 Sagadahoc, sixteen hundred dollars, with two hundred dol-
23 lars additional for clerk hire.
24 Somerset, eighteen hundred dollars, with three hundred dol-
25 lars additional for clerk hire.
26 Waldo, twelve hundred dollars, with two hundred dollars
27 additional for clerk hire.
28 Washington, fifteen hundred dollars, with three hundred dol-
29 lars additional for clerk hire.
30 York, eighteen hundred dollars, with five hundred dollars
31 additional for clerk hire.

The sums above mentioned shall be in full compensation for
33 the performance of all duties required of clerks by law,
34 including those performed by them as clerks of the supreme
35 judicial, superior and county commissioners' courts, or by
36 clerks pro tempore employed by them under section six of
37 chapter eighty. They shall account quarterly under oath to
38 the county treasurers for all fees received by them or payable
39 to them by virtue of the office, specifying the items, and
40 shall pay the whole amount of the same to the treasurers of
41 their respective counties quarterly on the first days of Jan-
42 uary, April, July and October of each year.

On the first day of January of each year the clerks receiving
44 the sums above specified for clerk hire shall make under oath
45 to the county treasurers of their respective counties a state-
46 ment specifying the amount paid by them for that purpose
47 and to whom paid during the year next preceding, and shall

48 pay to said treasurers any unexpended balance of such sums
49 in their hands.

Sect. 2. This act shall take effect on the first day of July,
2 one thousand nine hundred and five.
