Spain.

*Resolved,* That the sum of \$1342.75 be and is hereby appro-  
2 priated to reimburse the city of Portland for amount  
3 expended by said city for supplies furnished to families of  
4 soldiers during the late war with Spain.

## STATEMENT OF FACTS.

*To the Honorable City Council:*

The undersigned, special committee appointed in accordance with certain orders passed by this city during the year 1898, hereby beg to submit the following report.
