

## STATE OF MAINE.

RESOLVE in favor of King's Daughters' Union of Bangor.

Resolved, That the sum of five hundred dollars (\$500)

- 2 for the year 1907, and five hundred dollars (\$500) for the
- 3 year 1908, be and hereby is appropriated for the purpose of
- 4 assisting and maintaining the King's Daughters' Union of
- 5 Bangor.



#### STATEMENT OF FACTS.

The King's Daughters' Union is a charitable institution situated at Bangor, Penobscot County, Maine. It is a corporation duly organized under the laws of the State of Maine.

ITS PURPOSE.

The aim of this Home is to aid young girls by temporary shelter and help when they are in need, and also to assist them in fitting themselves to be self-supporting.

The Home is supported by contributions from different Circles of the King's Daughters, and also by the nominal board paid by those among its inmates who are able to pay.

The last three Legislatures have appropriated five hundred dollars (\$500) for each year to this institution, and the managers believe that it is necessary that this appropriation should be continued if the work is to be continued and extended. The corporation now has a good-sized house and large lot which is free from debt, having been given to the Home, but this property, while it allows the institution to accomplish more good, also means greater expenses. The Home also has an endowment fund of eighteen thousand dollars (\$18,000), which has been contributed by different citizens of Bangor, which shows that people who see the most of its work believe in the institution.

During this last year the Home received two hundred sixtyone (261) persons, which is an increase over previous years. The Home is of more value to those from other places than Bangor than it is to residents of Bangor. It is used especially by young women who come here from other places. Its special purpose is to help those who are attempting to help themselves.

The total balance on hand January 1, 1907, was only \$173.67. The total income of the Home, including the State aid and voluntary contributions of all sorts, amounted to \$2,783.02, and the expenditures \$2,609.35.
