STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to amend the charter of the Swan's Island Telephone & Telegraph Company, chapter 50, Private and Special Laws of the state of Maine for the year 1903.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section 2 of chapter 50 of the Private and

- 2 Special acts for the year 1903, be and hereby is amended by
- 3 striking out of said section the words "to Burnt Point" and
- 4 the words at the end of said section "thence to any point in
- 5 said Swan's island," and by inserting after the word "Lopaus
- 6 Point" the following: 'or Bass Harbor Head,' and by insert-
- 7 ing between the words "thence" and "across" the following
- 8 words: 'from either of said points;' and by inserting in place
- 9 of the words "to Burnt Point," which have been stricken

10 out: 'And across the islands in said bay, or forming the southerly boundary thereof to a convenient point,' and by 12 adding to said section the following: 'Also from any point 13 in the town of Brooklin, Hancock county, Maine to Naskeag 14 Point in said Brooklin; thence across Jericho bay so called 15 and the islands in said bay, or forming the easterly boundary 16 thereof to a convenient point in said Swan's island; thence 17 to any point or points therein; said lines to be land lines or 18 cable as may be appropriate; and the right to maintain an 19 exchange and telephone system throughout all parts of said 20 Swan's island,' so that said section as amended shall read as 21 follows:

'Said corporation shall have the right to locate, construct, 23 maintain, operate and own lines of telephone and telegraph 24 from any point in the village of Bass Harbor, town of 25 Tremont, Hancock county, Maine, to Loupaus Point, or Bass 26 Harbor Head so called in said Tremont; thence across Blue-27 hill bay and across the islands in said bay, or forming the 28 southerly boundary thereof, to a convenient point in Swan's 29 island in said county; also from any point in the town of 30 Brooklin, Hancock county, Maine, to Naskeag Point in said 31 Brooklin; thence across Jericho bay so called and the islands 32 in said bay, or forming the easterly boundary thereof, to a 33 convenient point in said Swan's island; thence to any point 34 or points therein; said lines to be land lines or cable, as may 35 be appropriate; and the right to maintain an exchange and 36 telephone system throughout all parts of said Swan's island.'

Sect. 2. This act shall take effect when approved.
